### 1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

#### 2. Petition

TAB – Mrs G. Godfrey presented a petition from 83 persons asking the Legislative Assembly to ensure that any sale of the TAB does not proceed (P. 270).

### 3. Papers

The Minister for Youth on the 21st anniversary of Youth Focus, an independent not-for-profit organisation working to prevent youth suicide.

The Minister for Environment on the appointment of Dr Thomas Hatton as Chairman of the Environmental Protection Authority Board and the re-appointment of Mr Robert Harvey as the Deputy Chairman of the Board.

The Parliamentary Secretary to the Minister for Commerce on the recent decision by BHP Billiton Iron Ore to jointly fund a round of the State Government's Industry Facilitation and Support Program.

# 5. Suspension of Standing Orders – Constitution Amendment (Recognition of Aboriginal People) Bill 2015
