THURSDAY, 26 JUNE 2014

1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Alinjarra Primary School – Ms J.M. Freeman presented a petition from 45 persons requesting that the Legislative Assembly gives urgent attention to the Alinjarra Primary School community's request for priority installation of electronic school zone signage (P. 148).

Freeman presented a petition from 1 person requesting that the Legislative Assembly gives urgent attention to the housing needs of Kidane Gebremedhin Tsagy and her family, and also to the housing needs of all Western Australians who are currently suffering homelessness due to a critical shortage of housing (P. 149).

8. Joint Standing Committee on the Corruption and Crime Commission – Terms of Reference

The Speaker advised members that he had received a letter dated 25 June 2014 from the Chairman of the Joint Standing Committee on the Corruption and Crime Commission advising that the Committee had resolved to undertake an inquiry into the Corruption and Crime Commission being able to prosecute its own charges with the following terms of reference.

The Committee will identify:

- (a) the operation of the State's prosecution system in relation to Corruption and Crime Commission matters;
- (b) whether there is a need to create new criminal offences that capture corrupt conduct; and
- (c) arrangements for the prosecution of corrupt conduct and misconduct in other jurisdictions.

The Committee proposes to report to the House by 30 June 2015.

9. Parliamentary Superannuation Board – Change of Membership

The Leader of the House, pursuant to notice, moved,

That the member for Churchlands be appointed as a member of the Parliamentary Superannuation Board in accordance with the *Parliamentary Superannuation Act 1970* to fill the vacancy caused by the resignation of the member for Alfred Cove.

10. Amendment to the Standing Orders

The Leader of the House, pursuant to notice, moved,

- (1) That Standing Order 74 be amended by adding the following:
 - (2) If a notice of motion is for disallowance in accordance with section 42 of the *Interpretation Act 1984* or any other Act, it may remain on the Notice Paper for 60 sitting days without being moved. On the final day, the Speaker will announce it will be removed from the Notice Paper on the next sitting day.
- (2) That the Standing Orders be amended by adding the following Standing Order:

Disclosure of the Identity of Journalists' Informants

314. If the Assembly is considering whether to require a journalist to disclose an informant's identity it shall have regard to the public interest of having a free press when it does so.

11. Taxation Legislation Amendment Bill 2014

be introduced and read a first time.

The Minister for Finance presented an explanatory memorandum and bill read a first time.

The Minister for Finance moved, That the bill be now read a second time.

Mr D.A. Templeman moved, That the debate be adjourned.

12. Local Government Amendment (Regional Subsidiaries) Bill 2014

Mr R.S. Love, pursuant to notice, moved,

That a bill for "An Act to amend the *Local Government Act 1995* to enable local governments to form regional subsidiaries and to make consequential amendments to other Acts." be introduced and read a first time.

Question put and passed.

Mr R.S. Love presented an explanatory memorandum and bill read a first time.

Ordered, That the second reading of the bill be made an Order of the Day for the next sitting of the Assembly.

13. Electoral Amendment Bill 2014

The Order of the Day for the resumption of the debate upon the third reading of the bill was read. Debate resumed.

Speaker's Statement – Absolute Majority at Third Reading

The Speaker advised members that the third reading of the Electoral Amendment Bill 2014 needed to be passed with the concurrence of an absolute majority of the members of the House. The Speaker advised members that he would divide the house if there was a dissentient voice when putting the question on the third reading. If there was no dissentient voice, he would count the members present and declare the question to be carried by an absolute majority, if that was the case.

Schedule indicating the amendment made by the Legislative Council in the Taxi Drivers Licensing Bill 2013

No. 1

Clause 42, page 38, after line 29 — To insert —

- (7) Where under this section a person is directed to give any information, answer any question or produce any document or record
 - (a) that person cannot refuse to comply with that direction on the ground that the information, answer, document or record may tend to incriminate the person or render the person liable to any penalty; but
 - (b) the information or answer given, or document or record produced, by the person is not admissible in evidence in any criminal proceedings against the person other than proceedings for perjury.
