 - (iv) will big emitters in Western Australia (including Gorgon) be required to publicly report greenhouse gas emissions in the interests of accountability and transparency, and consistent with the condition you applied to Chevron's Wheatstone project?

I refer to the recent Northcliff fires and ask does the Minister have mapping showing prescribed burns in the area of the recent burns:

- (a) done in the last 5 to 10 years;

- (d) is this mapping publicly available, and if not, why not?
