- (2) the adequacy of Western Australia's emergency capacity and preparedness to respond to a safety or environmental incident involving FLNG; and
- (3) the role and responsibilities of the state and federal governments in relation to FLNG emergency situations.

The Committee will report to the House by 14 March 2015.
