1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

3. Speaker's Statement – Casting and Deliberative Votes

The Speaker advised members that only the Speaker can exercise a casting vote and other members, when in the Chair as either Deputy Speaker or Acting Speaker, retain their deliberative vote. It was only when the Speaker was absent through illness or other unavoidable cause that the Deputy Speaker filled the office and performed the duty of the Speaker, including exercising a casting vote only.

Members would still need to be on the right of the Chair to vote 'Aye' or on the left to vote 'No'. Any member who was unable to take a seat during a division would be required to occupy a position which was clearly visible but which did not block the view of the Tellers or the Clerks.
