- (a) has the Premier or his representatives made any direct approaches, in relation to conserving whale sharks, to countries where whale sharks are hunted and if so what countries and what was the nature of the approach; and
- (b) has the Premier or his representatives requested that the Federal Government make representations to countries where whale sharks are hunted in relation to conserving whale sharks and if so what countries and what are the details of the request?
