Initial answers to previous Questions on Notice by the Minister (and other Ministers) regarding records and archives outsourcing describe annualised expenditure by the government agencies for which information is available of at least \$3 million. On page 569 of the 2010–2011 State Budget, the fourth point refers to the lack of adequate storage space at the State Records Office, plus the lack of storage space for the State Art Collection. In relation the above, I ask:

- (a) as the Minister notes the problems with record storage and archiving in the State Budget, can the Minister detail the reasons for the problems and advise whether a problem exists in terms of the increasing costs of supplying records management services within a fully privatised model;
- (b) can the Minister detail how the Government knows it is getting value for money when some agencies cannot separately account for the cost of file retrievals versus the cost of storage services; and
- (c) what solutions are the Minister exploring to alleviate the storage problem for the State Art Collection?

3202. Mr J.N. Hyde to the Minister for Education

In light of a media statement from the Minister for Multicultural Interests which states that the launch of the directory follows the allocation of more than \$7 million in the 2010–2011 State Budget to support students who speak English in Western Australian schools and that the additional funding will provide intensive English programs for newly-arrived students for up to two years before they enrol in mainstream public schools, can the Minister confirm whether the \$7 million will support native English speakers or children who desperately need support with English as a second language?

3203. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to the 2010–2011 State Budget, page 567, item 81, Western Australian Museum, and I ask:

- (a) what is the quantum of income and number of fines collected under the *Maritime Archaeology Act 1973* in relation to:

- (ii) section 9, dealing with the plunder, damage or disturbance of maritime archaeological sites, and of the ships, relics or things within a protected zone, still set at just \$1,000 as it was in 1973;
- (iii) section 17(1), providing a \$500 fine for not reporting a found shipwreck or relic; and
- (iv) section 17(2), providing a \$100 fine for taking and not reporting any relic;
- (b) what are the costs in enforcing this Act; and
- (c) what amendments are proposed for the *Maritime Archaeology Act 1973*?

3204. Mr J.N. Hyde to the Minister for Culture and the Arts

In relation to the 2010–2011 State Budget and referring to page 575, Western Australian Art Gallery acquisitions have been kept to just \$230,000 in 2010–2011 plus forward years. What is the total expenditure on acquisitions in 2009–2010, and expected in 2010–2011, including remaining one for one donation commitments under the Ignite package?

3205. Mr J.H.D. Day to the Minister for Culture and the Arts

I refer to the 2010–2011 State Budget, page 567, Effective Allocation, Perth Theatre Trust, and I ask, what is the breakdown of costs and income plus capital expenditure for BOCS ticketing?

3206. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to page 568, service summary, Arts Industry Support in the 2010–2011 State Budget and the fact that the Minister's department has expended funds to join the International Federation of Arts Councils and Culture Agencies, and I ask:

- (a) what extra funding commitment has the Minister made for Western Australian artists and companies to benefit from the Australia Council for the Arts hosting the fifth World Summit on Arts and Culture in Melbourne, Australia, in October 2011; and
- (b) with reference to the mid-year statements on page 117, under Grant Savings, detailing International Showcase Arts Events (cessation) with a \$1.5 million cut in 2010–2011, does this also relate to the Premier's previous comments that there would be an arts component to the Commonwealth Heads of Government Meeting in October 2011, comments which are missing in his latest statement on CHOGM?

3207. Mr J.N. Hyde to the Minister for Culture and the Arts

The 2009–2010 mid-year financial projections on page 114 under Corrective Measures, 3% Efficiency Dividend, states that \$12 million of cuts have been implemented over the current year and forward estimates. Can the Minister please detail these cuts?

3208. Mr J.N. Hyde to the Minister for Culture and the Arts

In relation to the previous Labor Government's dedicated Ignite funding to His Majesty's Theatre and the Perth Theatre Trust, I ask:

- (a) has the commitment to replace the carpets at His Majesty's Theatre been fulfilled, and what was the final cost as against the budgeted cost;

- (b) has the commitment to replace the audio visual system at His Majesty's Theatre been fulfilled, and what was the final cost as against the budgeted cost; and
- (c) has the commitment for an extra \$600,000 to invest in performances been expended; and
  - (i) if so, on what; and
  - (ii) if not, why not?

3209. Mr J.N. Hyde to the Minister for Culture and the Arts

On page 568 of the 2010–2011 State Budget papers (arts budget) \$1.344 million is allocated for voluntary severance. In reference to this, I ask, how many jobs does this equate to, and what areas of the portfolio will these jobs be lost from?

3210. Mr J.N. Hyde to the Minister for Culture and the Arts

In relation to the 2010–2011 State Budget, I ask:

- (a) what organisations or individuals received literature or writing grants during 2009–2010, for how much, and for what purpose; and
- (b) what was the total allocation for literature and writing expenditure in 2009–2010 and what is the budgeted amount for 2010–2011?

3211. Mr J.N. Hyde to the Minister for Culture and the Arts

Page 568 of the 2010–2011 State Budget refers to defer and re-allocate spending – New Museum and Cultural Development, while the mid-year budget statements on page 117 include a total cessation of \$3.3 million in arts and culture funding to various arts grants from 2012–2013. In relation to this, I ask:

- (a) can the Minister explain what specific programs and funding amounts are being deferred or reallocated and to what are they being reallocated;
- (b) will the Minister also identify which individual programs will be cut each year commencing 2010–2011 through to 2013–2014; and
- (c) what individual amounts will be cut for each program and what impact is this likely to have on the arts and culture sector currently receiving this funding?

3212. Mr J.N. Hyde to the Minister for Culture and the Arts

In Assembly Estimates committee B, Wednesday 2 June 2010 (page E327) it was stated that for major performing arts companies funding is still in the budget with indexation according to the business cases that have been agreed to, along with any triennially funded organisations, meaning that these organisations have still got their funding. In relation this, I ask:

- (a) can the Minister please table all the agreed business cases; and
- (b) would the Minister list the funding amounts, including indexation and duration, for each company for:
  - (i) 2009–2010;
  - (ii) 2010–2011; and
  - (iii) future years agreed?

3213. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to the 2010–2011 State Budget, page 571, explanation note 2, and I ask, what sales of property and what expected amounts are included in the \$1.357 million for 2009–2010, and the \$332,000 for 2010–2011?

3214. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to page 567, Development and Strategy, in the 2010–2011 State Budget, and ask what funding, policy commitment and leadership the Minister has allocated to meeting the following recommendations of the Review of the Western Australian State Government Percent for Art Scheme (2003):

- (a) Recommendation 7, which relates to working with commissioning agencies and artists to investigate ways to secure the allocation of the full 1% to artwork commissions in all suitable projects and encouraging the commissioning agency, on suitable projects, to increase the percentage allocation for West Australian artworks;
- (b) Recommendation 9, which relates to attracting new government agencies to undertake artwork commissions and investigating sourcing alternative spaces and opportunities in addition to typical building projects; and

  - (ii) how much comes from other sources, detailing the sources and the amounts from each source; and
- (b) what are the details of the revenue (sources and amounts) listed under the item 'Other Revenue'?

(2) Will the Minister provide the same details as provided for (1) above for the financial years 2008–2009 and 2009–2010?

3216. Mr J.N. Hyde to the Minister for Culture and the Arts

What activities, projects or grants (other than the Better Beginnings Family Literacy Program) within the arts budget are being funded or subsidised by Royalties for Regions funds?

3217. Mr J.N. Hyde to the Minister for Culture and the Arts

The State Library of Western Australia offers a number of venues and spaces for hire for public displays, talks and activities. In relation to this, I ask:

- (a) who makes decisions on what groups are accepted and are there written guidelines;
- (b) please list all groups that have been refused since September 2008;

- (c) please list all groups that have made bookings and detail any fees, concessions or waiving of fees that were applied;
- (d) do listed commercial businesses such as the Australian Stock Exchange pay the same rate as not-for-profit community groups such as Thai-Australian Association of Western Australia; and
- (e) does the Venues and Equipment Fees Schedule operate on a cost-recovery basis?

3218. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to page 572 (venue management services) of the 2010–2011 State Budget, where it explains that the \$2 million increase in costs for management and promotion in 2010–2011 is due to reallocation of depreciation for the State Theatre Centre, and I ask:

- (a) can the Minister detail an update on whether private funding has been confirmed, and how much it will be; and
- (b) is the Government's entire \$1 million commitment likely to be accessed?

3219. Mr J.N. Hyde to the Minister for Culture and the Arts

In relation to the 2010–2011 State Budget, page 568, Service Summary, Venue Management and Art Gallery, I ask:

- (a) what proposals has the Minister received; and
- (b) what is the Department's evaluation of:
  - (i) new building additions to the Perth Institute of Contemporary Art in the cultural centre; and
  - (ii) any commitment to begin a new third floor addition to the Art Gallery of Western Australia?

- (c) what travel expenses have been claimed in relation to this Venice-based collection and future exhibitions?

3221. Mr J.N. Hyde to the Minister representing the Minister for Women's Interests

In addition to the answers supplied to Question on Notice No. 2698 by the Minister for Women's Interests, I ask:

- (a) could the Minister outline in detail the commitments the State Government will be making to the Federal Government's National Plan of Action to stop violence against women;
- (b) to what extent do these commitments reflect the National Council to Reduce Violence Against Women and Children's findings in their Time for Action report;



- (c) what particular commitments will be adopted to ensure Aboriginal women and women in regional and remote areas will be able to access appropriate services to stop violence against women; and
- (d) what levels of funding will be allocated to these commitments?

3222. Mr M. McGowan to the Minister for Regional Development

I refer to page 260 of the 2010–2011 State Budget papers, in particular, line item ‘Employees (Full-Time Equivalents)’, listed under Regional Investment and Regional Policy, and I ask:

- (a) of those full-time equivalents, how many are based permanently in the regions; and
- (b) where are they based?

3223. Mr M. McGowan to the Minister for Regional Development

I refer to the line item on page 261 of the State Budget papers regarding the Jigalong Essential Services Pilot, and I ask, what specifically will be funded in this pilot?

3224. Mr T.G. Stephens to the Minister for Regional Development

In reference to the Regional Prices Index (RPI) conducted in November 2007 and used as the basis for the District Allowance Offer:

- (a) will the Minister advise when the next RPI is to be conducted;
- (b) in view of the changed circumstances since the last RPI was conducted, as evidenced by the House & Land snapshots published on the Pilbara Development Commission’s website which demonstrate that costs in Hedland are now significantly higher than all other Pilbara towns, will the Minister ensure that the next RPI is undertaken soon; and
- (c) will any adjustment in District Allowance be awarded to the Port Hedland officers who have been disadvantaged by the relatively recent increased costs – increases which are not reflected in the November 2007 work upon which the District Allowances Offer has been based; and
  - (i) if not, why not?
