1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Death of Reginald John Tubby – a former Member of the Legislative Assembly

The Premier, without notice, spoke on the following motion,

That the House records its sincere regret at the death of Reginald John Tubby and tenders its deep sympathy to his family.

The motion was supported by Mr M. McGowan, Mr R.S. Love, Mr D.A. Templeman and Mr I.C. Blayney.

Question put and passed unanimously with members and officers of the Assembly standing in their places as a mark of respect.

3. Brief Ministerial Statements

Brief Ministerial Statements were made by -

The Minister for Culture and the Arts on the new exhibition currently on display at the Western Australian Museum: A History of the World in 100 Objects.

The Minister for Tourism on the 68th Tourism Ministers' Meeting on 19 February 2016.

The Minister for Local Government on the St Vincent de Paul Society Lotterywest grant provided to help with the construction of their new premises in Canning Vale.

5. Petitions

Train Station between Warnbro and Mandurah – Mr P. Papalia presented a petition from 50 persons asking the Legislative Assembly to call upon the Barnett Government to commit to funding and building a new train station between Warnbro and Mandurah before 2017 (P. 344).

Golden Bay Local Community Funding – Mr P. Papalia presented a petition from 18 persons asking the Legislative Assembly to call on the Barnett Government to allocate a fair share of profit from the proposed housing development at Golden Bay to local community projects (P. 345).

Police Station between Rockingham and Mandurah – Mr P. Papalia presented a petition from 38 persons asking the Legislative Assembly to call upon the Barnett Government to build a Police Station between Rockingham and Mandurah and to create tougher laws to address the concerns of the local community (P. 346).

Drug and Alcohol Support Services – Dr G.G. Jacobs presented a petition from 45 persons asking the Legislative Assembly to direct resources to create a detox unit at Esperance Hospital, an on-call acute mental health service at Esperance Hospital and to increase drug and alcohol counselling services in the community (P. 347).

Housing Authority Tenants – Mr F.M. Logan presented a petition from 33 persons asking the Legislative Assembly to call on the Barnett Government to immediately reverse its decision to change the income assessment for Housing Authority tenants, which now incorporates Centrelink and Veteran Affairs benefits and allowances as assessable income (P. 348).
