- (11) Given that Midland also services the Perth Hills and Avon regions will the Minister advise what activities the MRA is undertaking to stimulate investment in Midland and how much have those activities cost to date?

**3815. Mrs M.H. Roberts to the Minister for Emergency Services:**

- (1) What is the former Midland Fire Station, located at 162 Great Eastern Highway, currently being used for?
- (2) Is the property still a Department of Fire and Emergency Services' asset?
- (3) Will the current use be continuing into 2016?
- (4) Are there any future plans for the site and if so will the Minister detail them?

**3816. Mrs M.H. Roberts to the Minister for Transport:**

- (1) Will the Minister advise how many people including adults, infants and children are permitted to ride a motorised wheelchair (or gopher) at the same time?
- (2) Are there any exemptions that allow more than one person on a gopher at any given time?
- (3) If yes to (2), what are the exemptions?
- (4) Have there been cases where the operator of a gopher has been charged with causing the accident and injury to others, and if so, how many cases on an annual basis and what are the range of charges preferred?
- (5) Does the Department of Transport have any figures with regards to the amount of accidents involving gophers and if so will you detail that information?

**3817. Mrs M.H. Roberts to the Minister for Health:**

- (1) Is the Minister aware of the confused messages that Oncology patients are receiving from both Royal Perth Hospital and Fiona Stanley Hospital due to the transfer of the Oncology services from Royal Perth to Fiona Stanley?
- (2) Will the Minister advise why some patients are being told that they need to contact Fiona Stanley for their treatment to only be referred back to Royal Perth hospital?
- (3) Will the Minister tell me when cancer patients can expect certainty in their treatment and no longer have to guess where their treatment is going to take place?

- (4) Is the Minister aware that the transfer of oncology from Royal Perth Hospital to Fiona Stanley Hospital is worrying many cancer patients?
- (5) Will cancer patients living in my electorate be able to transfer to Midland Hospital in 2016, and if so, what will the process and the criteria be?

**3818. Mrs M.H. Roberts to the Minister for Health:**

- (1) Will the Minister please advise how many years that breast cancer patients can expect to continue to receive free yearly mammograms from the hospital where they have been treated after their treatment has finished?
- (2) Has the frequency of mammograms provided changed recently and if so why?
- (3) What was the frequency offered for persons who completed chemotherapy in 2012?
- (4) What was the total cost of mammography services in Western Australia in each of the following years: 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2013 and 2014?
- (5) What was the total number of mammograms performed in each of the following years: 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013 and 2014?
- (6) How many of the above mammograms were provided at no cost to the patient?

**3819. Mrs M.H. Roberts to the Minister for Health:**

- (1) Is the Minister aware that patients living in my Electorate of Midland who use the Oncology Services at Royal Perth Hospital have now been informed that they must travel to Fiona Stanley Hospital in Murdoch or Rockingham General Hospital to receive their treatment?
- (2) Is the Minister aware that for a patient to travel from suburbs such as Stratton, Jane Brook or Swan View using public transport to Fiona Stanley Hospital that they have to take a bus and two trains, as well as walking approximately 1.2 kilometres (from stop to stop and to the hospital) with an approximate travel time of 104 minutes one way not allowing for waiting time at stops and stations?
- (3) Is the Minister aware that for a patient to travel from suburbs such as Stratton, Jane Brook or Swan View using public transport to Rockingham General Hospital they have to take a bus and two trains, as well as walk almost 2 kilometres (from stop to stop and to the hospital) with an approximate travel time of 130 minutes one way not including waiting times at stops and stations?
- (4) Does the Minister understand the difficulties that this presents for cancer patients living in my electorate, many of whom are quite unwell, that will now have to travel to Fiona Stanley Hospital or Rockingham General Hospital to receive their treatment?
- (5) Will the Minister commit to ensure that public patients living in the Eastern Suburbs will have these services provided to them in the future by the new Midland privately run hospital when it opens:
  - (a) if yes, when can people expect to be transferred to the new hospital; and
  - (b) if not, why not?
