- (c) has the Minister taken part in any form of mediation with the parties involved in this matter;
- (d) if yes to (c), what dates did mediation occur; and
- (e) will the Minister review the Office of the Registrar of Indigenous Corporations involvement and conduct with regards to their dealings of this matter?

5807. Ms J. Farrer to the Minister representing the Minister for Aboriginal Affairs:
