1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

2. Speaker's Statement – Malaysia Airlines Flight MH17

The Speaker advised members that all members in the House were solemnly united as they acknowledged the devastating loss on 17 July 2014 of all 298 passengers and crew of Malaysian Airlines MH17. He stated that many Western Australians had been directly affected by the tragedy. Some members knew people whose lives were taken that day; some members knew their families or friends. He further stated that others could only feel profound compassion as they attempted to imagine how mothers, fathers, husbands, wives, sons, daughters, grandparents and beloved friends would go on living in the face of such loss.

The Speaker advised that, on behalf of all those present, and on behalf of the Western Australian community, he expressed a shared grief and the deepest of sympathy to all those people who had been affected by those terrible events. He invited all to stand and observe a minute of silence as a mark of respect for those lost, and also in sympathy for those left behind.

The Speaker's statement concluded with members and officers of the Assembly standing in their places as a mark of respect.
