## 1. Meeting of Assembly

Southgates Sand Dunes – Mr I.C. Blayney presented a petition from 44 persons asking the Legislative Assembly to request the Department of Planning work with the City of Greater Geraldton to preserve the Southgate Dunes (P. 395).

White Peak Road Intersection – Mr I.C. Blayney presented a petition from 351 persons asking the Legislative Assembly to improve the intersection of White Peak Road and North West Coastal Highway by adding a right turning lane as soon as possible (P. 396).

Traffic Congestion in Munster – Mr F.M. Logan presented a petition from 104 persons asking the Legislative Assembly to call on the Barnett Government to modify the layout at Stock Road to allow for the duplication of Beeliar Drive to continue and the Mayor Road and Rockingham Road roundabout to be widened to allow the free flow of traffic (P. 397).

Housing Authority Tenants – Mr F.M. Logan presented a petition from 69 persons asking the Legislative Assembly to call on the Barnett Government to immediately reverse its decision to change the income assessment for Housing Authority tenants, which now incorporates Centrelink and Veteran's Affairs benefits and allowances as assessable income (P. 398).
