1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

6. Courts and Tribunals (Electronic Processes Facilitation) Bill 2013

Message No. 23 dated 16 October 2013 from the Legislative Council was reported forwarding for concurrence a bill for "An Act -

- to provide for the use of electronic technology in relation to court proceedings and certain other proceedings, and the record of court proceedings and certain other proceedings; and
- to make consequential and certain other amendments to various Acts; and

• to amend the *Fines, Penalties and Infringement Notices Enforcement Act 1994* so that the Fines Enforcement Registry is responsible for the management of the process for the enforcement of the payment of certain fines and other amounts as soon as the fines are imposed or the amounts are payable,

and for related purposes."

The Deputy Premier moved, That the bill be read a first time.

Question put and passed.

The Deputy Premier presented an explanatory memorandum and bill read a first time.

Leave was granted to proceed forthwith to the second reading of the bill.

The Deputy Premier moved, That the bill be now read a second time.

The Parliamentary Secretary representing the Minister for Disability Services moved, That the bill be now read a second time.

Ms S.F. McGurk moved, That the debate be adjourned.

11. Taxi Drivers Licensing Bill 2013

Debate interrupted by the Chair (Mr R.S. Love speaking) and adjourned until a later stage of the sitting.

13. Speaker's Statement – Questions and Answers

The Speaker reminded members about the Standing Orders as they related to questions and answers. Questions should not contain lengthy preambles or opinion, unless it was necessary to render the question intelligible. Answers needed to be relevant to the question and Ministers were asked for their cooperation and compliance in keeping their answers succinct. The Speaker also advised that a supplementary question should be a single question, precise in content and without preamble, which was directly relevant to the original question or answer that immediately preceded the supplementary question. Members were also reminded that while interjections were disorderly, the House had always tolerated occasional interjections. However, loud and repeated interjections which had the effect of drowning out the member on their feet were not acceptable.

The Committee will inquire into and report on the organisational response within the Department of Health to the challenges associated with commissioning the Fiona Stanley Hospital.

In particular, the Committee will examine:

(1) the arrangements made by the Department to plan for and manage the transition to and commissioning of the new facility;

- (2) the oversight and governance of the project, particularly with respect to the communication of important information about progress with the commissioning of the hospital within the Department and to external stakeholders and the Executive; and
- (3) any implications for the commissioning of the Midland Health Campus and the Perth Children's Hospital.

The Committee intends to present its report by 10 April 2014.
