5508. Dr A.D. Buti to the Minister for Police:

Is the Minister aware that eight religious leaders were strip-searched at the electorate office of the Hon Julie Bishop MP, in Subiaco, in December 2014, and if so:

- (a) can the Minister provide the reason as to why this action was undertaken, and the legislative provisions that enabled this action; and
- (b) does the Barnett Government condone police conducting strip searches against peaceful protesters or protestors, not acting unlawfully or illegally?

5509. Mr B.S. Wyatt to the Minister for Environment:

I refer to your statement in the Legislative Assembly on 14 June 2016, that as at 14 June '200 Aboriginal rangers and Aboriginal people are employed delivering conservation outcomes on their own country', and I ask:

- (a) which Government agency engaged each of the 200 Aboriginal rangers;
- (b) if any of the 200 Aboriginal rangers or people were engaged by non-government organisations, but the cost covered by Government, which organisations engaged the 200 Aboriginal rangers or people, and how much did the WA Government pay to each organisations for the exclusive use for the employment of Aboriginal people to deliver conservation outcomes on their own country;
- (c) how much was spent by the WA Government in 2014, 2015 and 2016 engaging the 200 Aboriginal people; and
- (d) on what country were the Aboriginal people employed?

5510. Mr B.S. Wyatt to the Minister for Environment:

I refer to your statement in the Legislative Assembly on 14 June 2016, that in 2008 'some 15 Aboriginal people were engaged in employment for conservation outcomes on country', and I ask:

- (a) which Government agency engaged each of the 15 Aboriginal people;
- (b) if any of the 15 Aboriginal people were engaged by non-government organisations, but the cost covered by Government, which organisations engaged the 15 Aboriginal people, and how much did the WA Government pay to each organisations for the exclusive use for the employment of Aboriginal people to deliver conservation outcomes on their own country;
- (c) how much was spent by the WA Government in 2008 engaging the 15 Aboriginal people; and
- (d) on what country were the Aboriginal people employed?
