## 1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

### 2. Brief Ministerial Statements

Brief Ministerial Statements were made by –

The Minister for Regional Development on an update to reforms announced on 7 May 2015 to the way infrastructure and services are delivered to Aboriginal communities in Western Australia.

The Minister for Culture and the Arts on the passing of noted historian Professor Geoffrey Bolton.

The Minister for Road Safety on the 2015–16 Road Trauma Trust Account and the Run-Off-Road Crashes Program.

The Minister for Mines and Petroleum on the death of a worker at a mine site near Southern Cross.

### 3. Questions

Questions without Notice were taken.

Questions on Notice Nos 4474 to 4522 were asked.

## 4. Speaker's Statement – Appointment of the Clerk Assistant (Committees)

The Speaker advised members that Mathew Bates had been appointed to the role of Clerk Assistant (Committees). Prior to his appointment Mr Bates worked in the Legislative Assembly Committee Office as a Research Officer for two years, and then as a Principal Research Officer for four years. Mr Bates will take up the role on 10 October 2015.

#### 5. Petitions

Gene Technology Act 2006 – Mr D.T. Redman presented a petition from 28 persons asking that the Legislative Assembly call for an independent review of the *Gene Technology Act 2006* by a parliamentary committee and to call for the Office of Gene Technology Regulator to include

independent science on health and environmental safety risk assessments of GM crops, associated pesticides and GM food (P. 271).

Genetically Modified Crops Free Areas Act 2003 – Mr D.T. Redman presented a petition from 100 persons asking that the Legislative Assembly calls for an independent review of the *Genetically Modified Crops Free Areas Act 2003* by a parliamentary committee, and also that it supports GM-free farming and urges the Government to introduce farmer protection legislation to compensate farmers who suffer economic loss due to GM contamination (P. 272).

Local Government Rate Increases – Mr P.T. Miles presented a petition from 110 persons asking the Legislative Assembly to establish appropriate governing bodies guided by the rate of inflation to limit rate increases by local governments (P. 273).

City of Wanneroo – Mr P.T. Miles presented a petition from 391 persons requesting the Legislative Assembly to restrict the legal odour emission quota of Ingham Enterprises' operations in Sinagra under section 56 of the *Environmental Protection Act 1986* and that the renewal of Ingham's licence under the Act only be granted upon the condition that the company undertakes preparatory action to relocate operations away from the Wanneroo town site to prevent further debilitation (P. 274).

Royal George Hotel – Ms S. McGurk presented a petition from 398 persons requesting the Legislative Assembly to call on the State Government to ensure that prior to any sale there is a resourced and current heritage plan to restore the Royal George Hotel, and ensure that any development proposal is sympathetic to the building and in keeping with community expectations (P. 275).

Royal George Hotel – Ms S. McGurk presented a petition from 25 persons requesting the Legislative Assembly to call on the State Government to ensure that prior to any sale there is a resourced and current heritage plan to restore the Royal George Hotel, and ensure that any development proposal is sympathetic to the building and in keeping with community expectations (P. 276).
