2373. Mr D.A. Templeman to the Minister for Road Safety:

I refer to supplementary information B18 from the Office of Road Safety arising from Budget Estimates, and I ask:

- (a) Can the Minister please list the schools at which two people were killed when the reduced speed limit occurred, and the date of these incidents;
- (b) can the Minister please list the schools where 74 people were seriously injured, and the date these incidents occurred;
- (c) can the Minister please list the schools where 22 people were killed outside the reduced speed limit times, and the date these incidents occurred; and
- (d) for each of the above categories, can the Minister please outline how many of the victims attended the school in question?

2374. Ms S.F. McGurk to the Minister for Tourism:

I refer to the 2014 Rottnest Channel Swim and information I received that the water at the toilet block near the Kingstown Barracks was turned off during the swim and I ask:

- (a) can the Minister detail whether the water supply to a toilet block near the Kingstown Barracks was tuned off during the weekend of the 2014 Rottnest Channel Swim;
- (b) if yes to (a), why was the water at this toilet block was turned off on the busiest day of the year, and was water supply interrupted to any other facilities on the Island;
- how many visitors were estimated on the Island on the weekend of the 2014 Channel Swim, and how does this compare to the weekends before and after the swim;
- (d) what effect did the interruption to water supply have to people using public amenities; and
- (e) is the water supply on the Island not coping with current demand?

- (d) what will be the minimum floorspace of the lifts at each of the new hospitals (square metres);
- (e) what will be the physical size of the floorspace in two-bedroom wards and four-bedroom wards at each of the following:
 - (i) PCH;
 - (ii) FSH; and
 - (iii) MHC: and
- (f) what is the existing size of two-bedroom and four-bedroom wards at each of the following:
 - (i) Princess Margaret;
 - (ii) Kaleeya;
 - (iii) Fremantle; and
 - (iv) Midland Health Campus?

I refer to the KidsCulture program being piloted in Stirling and Albany in 2014, and I ask:

- (a) what is the duration of the pilot programs in both Stirling and Albany;
