2. Petitions

City of Fremantle – Ms S.F. McGurk presented a petition from 3,731 persons requesting that the Legislative Assembly supports new City of Fremantle boundaries that strengthen Fremantle as a unique and distinctive community of interest based on the Fremantle CBD as a strategic activity centre as defined under Directions 2031 (P. 137).

Rosehill Golf Course – Mrs G.J. Godfrey presented a petition from 100 persons requesting that the Legislative Assembly rejects the rezoning application for the Rosehill Golf Course (P. 138).
