# 3988. Ms M.M. Quirk to the Parliamentary Secretary representing the Minister for Mental Health:

When will promised laws to restrict or prohibit the supply of Kronic and analogues be introduced into Parliament and what is the reason for delay?

## 3989. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to proposed changes to the *Conservation and Land Management Act 1984* which confer on the Chief Executive Officer the power to manage fires on lands which come within that Act, and I ask:

- (a) whether the Minister agrees with this change;
- (b) how will this change impact on the powers of the Commissioner of Fire and Emergency Services to take over control of serious incidents; and

(c) isn't this amendment inconsistent with Keelty recommendations where departmental silos were found to be inimical to effective and timely fire management?

## 3990. Ms J.M. Freeman to the Minister representing the Minister for Housing:

I refer to the Department of Housing properties listed for sale in the *West Australian* newspaper on 28 February and ask:

- (a) how much was spent on improvements prior to listing;
- (b) what is the expected revenue from the sale of these properties;
- (c) will the housing stock be replaced, and if so; and
- (d) how many new housing units will replace them?
