- (a) are there any entities that Verve Energy believes are part of the joint venture that are not referred to in Verve Energy's annual report and if so, what is the relationship between Verve Energy, Wind Energy Corporation Pty Ltd and this other or these other entities; and
- (b) what assets are held by each entity in this joint venture, including Wind Energy Corporation Pty Ltd and have any assets of these assets been transferred to any of these entities or this entity by Verve Energy, and if so, what assets have been transferred, and on what dates?

**930. Mr W.J. Johnston to the Minister for Energy:**

I refer to Wind Energy Corporation Pty Ltd, and I ask:

- (a) is Wind Energy Corporation Pty Ltd, referred to Verve Energy in its *2011–2012 Annual Report* as a joint venture, in fact a company limited by shares and if so, why does Verve Energy use the term joint venture;
- (b) does Verve Energy own any shares in Wind Energy Corporation Pty Ltd and if so, how many;
- (c) was there any consideration paid by Verve Energy for this share/these shares in Wind Energy Corporation Pty Ltd and if so, what was this consideration, and to whom was this consideration paid; and
- (d) either prior to or subsequent to Verve Energy taking ownership of this share or these shares, has Verve Energy transferred any assets to Wind Energy Corporation Pty Ltd, and if so, what assets and on what dates?

**931. Mr W.J. Johnston to the Minister for Energy:**

I refer to Mumbida Wind Farm Pty Ltd, and I ask:

- (a) prior to the decision to enter into the Mumbida Wind Farm Pty Ltd joint venture, was there a business case prepared for the project and if so, who prepared this business case; and
- (b) did this business case include any engineering analysis and if so, who prepared this analysis?

**932. Mr W.J. Johnston to the Minister for Energy:**

- (1) I refer to Mumbida Wind Farm Pty Ltd, and I ask, has any capital been paid into Mumbida Wind Farm Pty Ltd by any entity other than Verve Energy and if so:
  - (a) on what dates;
  - (b) in what amounts; and
  - (c) by whom?
- (2) Will the Government require Verve Energy to publish the accounts of Mumbida Wind Farm Pty Ltd, and if not why not?

**933. Mr W.J. Johnston to the Minister for Energy:**

I refer to Mumbida Wind Farm Pty Ltd, and I ask:



- (a) what value was placed by Verve Energy on its ownership of 50 per cent of Mumbida Wind Farm Pty Ltd joint venture on each of these dates:
  - (i) 30 June 2011;
  - (ii) 30 June 2012; and
  - (iii) 31 March 2013; and
- (b) has any capital been paid into Mumbida Wind Farm Pty Ltd joint venture by Verve Energy and if so, on what dates, and in what amounts?

**934. Mr W.J. Johnston to the Minister for Energy:**

I refer to Mumbida Wind Farm Pty Ltd, and I ask:

- (a) since September 2008, on what specific dates did Cabinet consider matters relating to the Mumbida Wind Farm Pty Ltd joint venture;
- (b) on what date did Cabinet approve the initial capital injection by Verve Energy into the Mumbida Wind Farm Pty Ltd joint venture and what amount of money did Cabinet approve for Verve Energy to spend on this project at that time; and
- (c) has Cabinet subsequently approved further injections of money by Verve into the Mumbida Wind Farm joint venture and if so, when and what amount of money each time?

**935. Mr W.J. Johnston to the Minister for Energy:**

I refer to Mumbida Wind Farm Pty Ltd, and I ask, was there a competitive tender process to choose the head contractor to complete the engineering works on the joint venture, and if not, why not?
