THURSDAY, 27 JUNE 2013

1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Churchlands Senior High School – Mr S.K. L'Estrange presented a petition from 52 persons requesting that the Legislative Assembly directs the Education Department architects to increase the proposed boundary and road setbacks in the building of a classroom block at Churchlands Senior High School, and to consult with residents on this process (P. 22).

Guildford Road and Colstoun Road intersection – Mr D.J. Kelly presented a petition from 459 persons requesting that the Legislative Assembly agrees to install traffic lights and provide better access on the footpath and bikepath at the intersection of Guildford Road and Colstoun Road in Ashfield (P. 23).

Disability Justice Centres – Mr D.J. Kelly presented a petition from 69 persons requesting that the Legislative Assembly finds more appropriate locations for two disability justice centres to be located at Lord Street and Altone Road in Lockridge (P. 24).

Drovers Place and Joondalup Drive intersection – Mr P.T. Miles presented a petition from 1,856 persons requesting that the Legislative Assembly makes provision for an urgent meeting between Main Roads and the City of Wanneroo's Director of Roads in order to instruct the City to improve the road network and install traffic lights at the intersection of Drovers Place and Joondalup Drive (P. 25).

Australian Marine Complex – Mr F.M. Logan presented a petition from 439 persons requesting that the Legislative Assembly establishes a permanent, full staffed emergency medical facility within the Australian Marine Complex (P. 26).

Disability Justice Centres – Ms R. Saffioti presented a petition from 26 persons requesting that the Legislative Assembly finds more appropriate locations for two disability justice centres to be located at Lord Street and Altone Road in Lockridge (P. 27).
