- (1) Has traffic modelling been conducted to assess the impact to traffic flow, parking and surrounding homes and businesses at Hampton Park Primary School?

- (g) how does the Minister intend to deal with matters including actual projects and proposals through to matters of policy and procedure that will be dealt with by the EPA in which Dr Limerick has a conflict of interest, or from which he may benefit?

- (c) how many alcohol interlock devices have been fitted since June 2015 and what has been the total cost of these devices; and
- (d) what procedures are being used to measure the success of the Government's alcohol interlock program?

In connection to your media statement dated Saturday 21 February 2015 where you announced a long term road safety camera plan, I ask:

- (a) what has been the increase in each camera category namely, red light, fixed, point to point cameras, and hours of mobile speed operations from that date until 31 January 2016;

- (c) on a month by month basis, from February 2015 to 31 January 2016, how many mobile speed cameras have been in operation by the WA police; and
- (d) how many hours per month, from February 2015 to 31 January 2016, are the mobile speed cameras being used?

  - (b) how many FTE staff are currently employed there;
  - (c) will all existing staff at Bentley maternity have the option of redeployment elsewhere within WA Health, or will there be some involuntary redundancies; and
  - (d) how many women in total, who planned to have their baby at Fiona Stanley Hospital, were bypassed, and/or diverted or and/or transferred to birth at Bentley maternity since December 2014?
- (2) I refer to the Report on the Review of Maternity Services other recommendations and ask:
  - (a) will you conduct a Review into Maternity Services at Fiona Stanley Hospital;
  - (b) how much additional funding and resources will you allocate to maternity services at Osborne Park Hospital;
  - (c) what is the Department of Health doing to expand the Midwifery Group Practice (MGP) model of care;
  - (d) which hospitals already provide an MGP model;
  - (e) which other hospital(s) is the Department of Health committed to extending the MGP model to, and what is the timeframe for implementing the MGP at these other hospital(s); and

- (f) how much money will be allocated to expanding secondary neo-natal facilities, listed by amount per hospital and when will the allocation be made available?

**5003. Mr B.S. Wyatt to the Minister representing the Minister for Housing:**

Is the Department of Housing engaging with the Department of Child Protection as part of the 'Stronger Families' program, and if so:

- (a) how many cases is the Department of Housing engaged with; and
- (b) on average, how regularly is the Department of Housing meeting with clients and the Department of Child Protection under the 'Stronger Families Program'?

**5004. Mr B.S. Wyatt to the Minister representing the Minister for Housing:**

I refer to evictions of public housing tenants in Newman and ask:

- (b) of these, how many were evicted on the grounds of:

I refer to maintenance from public housing tenants in Newman and ask:

- (b) how many of these maintenance requests were completed from 1 January 2015 to date;
- (c) how many properties have been left vacant due to maintenance works to be completed in 2015; and
- (d) what was the average waiting time these properties were left vacant?

**5006. Mr D.J. Kelly to the Minister for Water:**

- (1) Is the WA College of Agriculture in Denmark using scheme water for its dairy farm despite having a dam specifically for this purpose?
- (2) If yes, why and how much scheme water has been used each month for the last year?

**5007. Ms R. Saffioti to the Minister for Transport:**

I refer to the Government's Ellenbrook Bus Rapid Transit project and ask:

- (a) is it still the Government's intention to proceed with the project;
- (b) what plans currently exist for the project; and
- (c) when will the planning process for the project be complete?
