WEDNESDAY, 10 MARCH 2010

1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Commercial Growing of Genetically Modified Canola – Petitions requesting that the Legislative Assembly reverse the decision to allow commercial growing of genetically modified canola in Western Australia were presented by –

Mr G.M. Castrilli from 61 persons (P. 238);
 Mr A.J. Simpson from 17 persons (P. 239);
 Mrs L.M. Harvey from 20 persons (P. 240);
 Mr C.J. Tallentire from 101 persons (P. 241); and
 Mr A.J. Waddell from 20 persons (P. 243).

Urban Development South of the Moore River – Ms A.S. Carles presented a petition from 78 persons requesting that the Legislative Assembly support the recommendation that the land adjoining the proposed Wilbinga Conservation Park be protected from future development (P. 242).

- repeal the *Debits Tax Assessment Act 2002*,

and to provide for related and consequential matters.” be introduced and read a first time.

The Minister for Agriculture and Food moved, That the bill be now read a second time.

Mr D.A. Templeman moved, That the debate be adjourned.

Page 7, lines 3 and 4 — To delete the lines and substitute:

“

Aboriginal land means —

- (a) Crown land; or
- (b) freehold land that is owned by AAPA, ALT or the State, over which an Aboriginal entity has power to grant a lease;

”.

Page 10, line 10 — To delete “agreement;” and substitute:

“ agreement, but only if the parties to the agreement agree to the early termination; ”.

Amendments agreed to.

Clause, as amended, agreed to.

Clauses 10 and 11 agreed to.

Title agreed to.

Consideration in detail concluded.

Ordered, That the third reading of the bill be made an Order of the Day for the next sitting of the Assembly.
