# Questions listed for this sitting: -

#### 7. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media comments reported in *The West Australian* of 12 April 2013 that the decision to merge Verve and Synergy had been made in the two weeks prior to 10 April 2013, and I ask:

- (a) prior to 26 March 2013, what issues made the Minister sceptical of the merits of merging Verve and Synergy;
- (b) what reports, documents, studies or other information which came into the Minister's possession after 26 March 2013 did he rely on to change his view to support the merging of Verve and Synergy (please provide the specific title, date and author of each of these reports, documents or studies);
- (c) when did the Minister first receive these reports, documents or studies; and
- (d) will these reports, documents or studies be tabled?

### 8. Ms R. Saffioti to the Minister for Transport:

I refer to the Premier's answers to questions from the media on 4 March 2013, regarding the State Government's plan to develop a Bus Rapid Transit system to Ellenbrook, in which the Premier replied that no, we're not going to do that, and ask:

- (a) is the State Government committed to delivering the Ellenbrook Bus Rapid Transit system;
- (b) when will State Government commence building the Ellenbrook Bus Rapid Transit system;
- (c) will the Minister be releasing the concept design work for public comment?

#### 9. Ms R. Saffioti to the Minister for Transport:

Will the Minister provide a list of all stakeholders that were consulted as part of the concept design work for the Ellenbrook Bus Rapid Transit System?

# 10. Ms R. Saffioti to the Minister for Transport:

What was the total cost of the *Ellenbrook Bus Rapid Transit Public Transport Options Study* produced by Sinclair Knight Merz and published on 17 June 2011?

#### 11. Ms R. Saffioti to the Minister for Transport:

I refer to the State Government's commitment to build a dual carriageway on Gnangara Road, between Drumpellier Drive and Alexander Drive, and ask:

- (a) when is work scheduled to begin; and
- (b) when will works be completed and the new road opened?

# 12. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media comments reported in *The West Australian* dated 12 April 2013 stating that he had been in the job for two weeks and come across a number of reasons for merging Verve and Synergy, and I ask:

- (a) what are these reasons; and
- (b) who provided each of those reasons, and on what dates?

### 13. Ms R. Saffioti to the Minister for Transport:

I refer to Gnangara Road, east of Pinaster Parade, and ask:

- (a) has the Government received any submissions from anyone asking that the speed limit on Gnangara Road be reduced to 50km/h; and
- (b) is the Government considering this option?

## 14. Ms R. Saffioti to the Minister for Transport:

I refer to the proposed upgrade of the Lord Street and Reid Highway intersection, which was originally set for completion in late 2012, and ask:

- (a) when will construction begin; and
- (b) what is the new completion date?

## 15. Ms R. Saffioti to the Minister for Transport:

I refer to the election commitment to begin construction of the 37km section of the Perth-Darwin National Highway in 2016 and be completed in 2019, and ask:

- (a) has planning and project development work for the project been completed;
- (b) what consultation has the State Government undertaken with landowners who will reside in close proximity to the new highway;
- (c) if no consultation has yet been undertaken, what plans are in the place to consult with this landowners and residents; and
- (d) will the Minister confirm that the project will be completed in 2019?

# 16. Ms R. Saffioti to the Minister for Transport:

I refer to the State Aviation Strategy, and ask:

- (a) does the Minister have the final report;
- (b) will the Minister release the report for public consultation; and
- (c) does the report consider the potential for Royal Australian Air Force Base Pearce to support civil operations?

#### 17. Ms R. Saffioti to the Minister for Transport:

I refer to the State Government's announcement in December 2012 to construct a \$75 million overpass at the intersection of Malaga Drive and Reid Highway, and ask:

- (a) has planning and design of the overpass been completed;
- (b) when will construction begin; and
- (c) when will construction be completed and the project finished?

#### 18. Ms R. Saffioti to the Minister for Transport:

I refer to the election commitment to install flashing 40m/h school zone signs outside South Ballajura Primary School and ask:

- (a) will the flashing signs be installed on both Hamelin Drive and Wyperfeld Garden outside the primary school;
- (b) if not, which road will the flashing signs be installed on; and
- (c) will the Minister consider installing the flashing signs on both roads?

# 19. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media release dated 10 April 2013 entitled *Major Reform for State's Energy Sector*, and I ask:

- (a) with regard to the gas supply contract between the Gorgon joint venture and the existing Synergy:
  - (i) when does the contract come into effect;
  - (ii) how long will the contract last;
  - (iii) what are the total annual gas volumes; and
  - (iv) what is the contracted maximum gas volume;
- (b) has there been any study or examination as to the relative price paid under these contracts;
- if yes to (b), when was this study performed, who performed it, what is its name, and how was the Minister advised of its outcome, and on what date was he advised;

- (d) has there been any study done to compare these prices with any other prices for gas in the Western Australian gas market; and
- (e) if yes to (d), when was this study performed, who performed it, what is its name, and how was the Minister advised of its outcome, and on what date was he advised?

#### 20. Ms R. Saffioti to the Minister for Police:

I refer to Question of Notice No. 8524 answered on 16 October 2012 and the subsequent commitment made by the State Government to build a \$12.5 million police station in Ballajura within three years, and ask:

- (a) what evidence was presented to the Minister that service delivery in Ballajura had been significantly negatively affected by the State Government's decision to close the station in 2009:
- (b) will the Minister table this evidence;
- (c) if not, why not; and
- (d) when did the Minister advise the Police Commissioner of the decision by the State Government to now build a new station in Ballajura?

### 21. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media comments reported in *The West Australian* dated 11 April 2013 stating that the real question is what kind of market structure and incentives, three, four or five years down the track will there be to encourage providers not only to build and sell power to Synergy, but to take more of the market risk, and I ask:

- (a) what kind of market structure and incentives will there be on 1 July 2013 to encourage private investors not only to build and sell to Synergy, but to take more of the market risk;
- (b) are these market structures and incentives contained in a set of published rules or other documents;
- (c) if yes to (b) are these available to the community, including investors, and if so, from where are they available; and
- (d) if yes to (b) what is the title(s) of these rules or other documents, who is their author and what are they dated?

## 22. Ms R. Saffioti to the Minister for Police:

I refer to the election commitment to build a \$12.5 million police station in Ballajura and ask:

- (a) will this station be completed in 2015-2016;
- (b) what process will the State Government undertake to choose the greenfields site where the station will be constructed;
- (c) when does the State Government plan to commence construction;
- (d) will the station accommodate 21 police officers;
- (e) will the station be open on a 24-hour basis;
- (f) how many holding cells will the station contain;
- (g) will the station contain secure parking for officers; and
- (h) what suburbs will the station be responsible for?

#### 23. Ms R. Saffioti to the Minister for Police:

I refer to the State Government's \$11.7 million commitment to upgrade Morley Police Station and to house 80 Police Officers in the new upgraded facility, and ask:

- (a) when will the upgrade be completed; and
- (b) which stations will the 80 Police Officers be sourced from?

#### 24. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media release dated 10 April 2013 entitled *Major Reform for State's Energy Sector*, and I ask:

- (a) is there a plan for the future generational needs of Western Australia;
- (b) if yes to (a), is this plan contained in a document, and if so, what is the name of this document, what is the date of this document, and who is its author; and
- (c) if yes to (a), will the Minister table this document?

#### 25. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media release dated 10 April 2013 entitled *Major Reform for State's Energy Sector*, and I ask:

- (a) does the Government intend to quit the generation of electricity;
- (b) if yes to (a):
  - (i) when is it planned that the Government will quit the generation of electricity;
  - (ii) does the plan include a mechanism for quitting electricity generation;
  - (iii) when was this plan created; and
  - (iv) is this plan contained in a document, and if so, what is the name of the document, what is it dated, who is its author and when was the Minister provided with this document:
- (c) if no to (a):
  - (i) why is the Minister quoted in *The West Australian* dated 11 April 2013 saying that he did think that the Government would slowly exit generation?

# 26. Mr W.J. Johnston to the Minister for Energy:

I refer to the Minister's media release dated 10 April 2013 entitled *Major Reform for State's Energy Sector*, and I ask:

- (a) does the Government have a fully developed plan to deal with all the issues that arise from the merging of Verve and Synergy;
- (b) if yes to (a):
  - (i) when was this plan created; and
  - (ii) is this plan contained in a document, and if so, what is the name of the document, what is its date, who is its author and when was the Minister provided this document;
- (c) if no to (a):
  - (i) was the decision to merge Verve and Synergy made pursuant to a decision of Cabinet; and
  - (ii) is it the policy of the current State Government to merge valuable State-owned assets without a comprehensive plan?

## 27. Ms R. Saffioti to the Minister for Planning:

I refer to Question on Notice No. 8552 answered on 16 October 2012, and given the State Government's election commitment to begin construction of the Perth-Darwin National Highway on the new alignment in 2016, I ask:

- (a) will a new Sub-Regional Structure Plan be produced for the Swan Urban Growth Corridor; and
- (b) when does the Minister intend to publish an updated structure plan?

#### 28. Ms R. Saffioti to the Minister for Planning:

I refer to the 1.5ha set aside as part of the Perth Waterfront Project for an Indigenous Cultural Centre and ask:

- (a) is the State Government still committed to building the Centre at Elizabeth Quay;
- (b) what is the estimated cost;
- (c) will the State Government seek funding from the Federal Government to help fund the construction costs; and
- (d) when is construction due to commence?

#### 29. Ms R. Saffioti to the Minister for Sport and Recreation:
