Health System Jobs – Mr M. McGowan presented a petition from 1796 persons requesting that the Legislative Assembly commits to protect jobs in health, and engage all stakeholders, including staff and unions, in a consultation process before any final determinations are made regarding health workers (P. 334).

Perth Freight Link: Roe Highway Extension – Mr P.C. Tinley presented a petition from 382 persons requesting that the Legislative Assembly calls on the Barnett Government to reverse the decision to allow Roe 8 Highway (eastern end of the Perth Freight Link) to go ahead and to support requests by the residents of the City of Cockburn, the sons and daughters of the AWAS women and the RSL City of Cockburn sub branch to preserve, and not destroy this site (P. 335).

Perth Freight Link: Roe Highway Extension – Mr P.C. Tinley presented a petition from 417 persons asking the Legislative Assembly to call on the Barnett Government to reverse their decision to allow the Roe Highway Extension (eastern end of the Perth Freight Link) to go ahead and to allocate the funding awarded to this project to other alternative solutions to freight transfer issues (P. 336).
