TUESDAY, 17 NOVEMBER 2015

1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Speaker's Statement – Terrorist Attacks

At the request of the Speaker, members stood and observed a minute's silence as a sign of respect to the victims of the recent terrorist attacks in Paris, Beirut and various other places.

3. Brief Ministerial Statements

5. Speaker's Statement – Longest Serving Female Member of the Western Australian Parliament

The Speaker advised members that on 8 November, the member for Midland, the Hon Michelle Roberts, became the longest serving female member of the Western Australian Parliament.

Ms Roberts' service, a total of 21 years, 7 months and 20 days, has surpassed the previous longest serving female member Elizabeth Constable, who retired in 2013, also after a period of more than 21 years.

6. Speaker's Statement – Procedural Situation

The Speaker advised members of a procedural situation which occurred on Thursday 12 November.

The consideration in detail stage had concluded on the Perth Market (Disposal) Bill 2015 and, after some discussion, the House agreed to a motion that the third reading of the Bill be made an Order of the Day for the next day's sitting. However, it became clear immediately following this that the Government wanted to move the third reading forthwith and the Leader of the House, acting on advice, moved to rescind the vote. This was agreed to by the House.

The Speaker advised that such a motion requires notice or a suspension of standing orders, neither of which occurred. However, as the rescission had the support of the House and was procedural in nature, the Speaker does not consider that any further action needs to be taken, but advised that this should not be taken as a precedent.

7. Petitions

Reform of Sex Offender Laws – Mr P.C. Tinley presented a petition from 183 persons asking the Barnett Government and the Legislative Assembly respond to a review of sex offender laws, and improve the supervision of sex offenders that have been released, and to urgently introduce legislation into the Parliament to improve these laws to make our community safer (P. 318).

Perth Freight Link: Roe Highway Extension – Mr P.C. Tinley presented a petition from 65 persons requesting the Legislative Assembly to call on the Barnett Government to reverse their decision to

allow the Roe Highway Extension (eastern end of the Perth Freight Link) to go ahead and to allocate the funding awarded to this project to other alternative solutions to freight transfer issues (P. 319).

Drug and Alcohol Support Services – Dr G.G. Jacobs presented a petition from 500 persons asking the Legislative Assembly to direct resources to create a detox unit at Esperance Hospital, an on-call acute mental health service at Esperance Hospital and to increase drug and alcohol counselling services in the community (P. 320).

Woodbridge Primary School – Mrs M.H. Roberts presented a petition from 288 persons asking that the Minister for Education and the Barnett Government acknowledge that Woodbridge Primary School and Guildford Primary School are already operating at capacity and call upon the Government to abandon its plans for demountable classrooms at Woodbridge Primary School and immediately commit to re-opening Midland Primary School (P. 321).
