WEDNESDAY, 11 MAY 2016

1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Housing Authority Tenants – Mr F.M. Logan presented a petition from 58 persons asking the Legislative Assembly to call on the Barnett Government to immediately reverse its decision to change the income assessment for Housing Authority tenants, which now incorporates Centrelink and Veteran's Affairs benefits and allowances as assessable income (P. 366).

South Beach Estate – Ms S. McGurk presented a petition from 77 persons asking the Legislative Assembly to support a neighbourhood-wide speed reduction within the South Beach Estate to 40 km/hr, ensuring that traffic is travelling at a pace that poses less danger for residents (P. 367).

Intersection of Rollinson and Cockurn Roads – Ms S. McGurk presented a petition from 75 persons asking the Legislative Assembly to support an urgent and immediate upgrade of the intersection of Rollinson and Cockburn Roads in North Coogee (P. 368).

Bus Routes in Coolbellup – Mr P.C. Tinley presented a petition from 8 persons asking the Legislative Assembly to ensure that Route 513 is left unchanged so that residents of Hale House and surrounding homes retain access to nearby bus stops that have a direct route to Fremantle and Murdoch Station (P. 369).

Quinns Beach – Mr A.P. Jacob presented a petition from 159 persons asking the Legislative Assembly to support the allocation of funds towards the proposed project of a beach enclosure being installed at Quinns Beach (P. 370).
