WEDNESDAY, 9 NOVEMBER 2016

1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Helena Aurora Range – Mr C.J. Tallentire presented a petition from 201 persons asking the Legislative Assembly to grant full and secure protection to the Helena Aurora Range (Bungalbin) through the gazettal of the area as a Class A Reserve and National Park (P. 413).

Community Child Care – Mr W.J. Johnston presented a petition from 25 persons asking the Legislative Assembly to call on the Barnett Government to retain the funding to community child care and neighbourhood centres (P. 414).

Early Childhood Centres – Mr W.J. Johnston presented a petition from 162 persons asking the Legislative Assembly to call on the Liberal Government to give community-based early childhood centres and the families that rely on them certainty and reverse the decision to cut the accommodation assistance (P. 415).

Save Western Power – Mr W.J. Johnston presented a petition from 101 persons asking the Legislative Assembly to stand against the Barnett Government's privatisation of Western Power (P. 416).

Georgiana Molloy Anglican School – Ms L. Mettam presented a petition from 250 persons asking the State Government to implement safety improvements at Georgiana Molloy Anglican School (P. 417).
