**APPROPRIATION
(CONSOLIDATED FUND) BILL
(No. 4) 1998**

A BILL FOR

AN ACT to appropriate out of the Consolidated Fund a sum for capital payments made during the year ended 30 June 1997 under the authority of the *Treasurer's Advance Authorization Act 1996*.

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 4) 1998*.

Commencement

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Appropriation of purpose

5 3. The sum of \$19,277,873.88 being payments of an extraordinary or unforeseen nature made under the authority of the *Treasurer's Advance Authorization Act 1996* and charged to the Consolidated Fund under that Act, is appropriated for the capital services and purposes expressed in Schedule 1.
