A Bill for

An Act to provide for the issue of a document known as a Western Australian Photo Card and for related purposes.

The Parliament of Western Australia enacts as follows:

Part 1 — Preliminary

1		Part 1 — Preliminary
2	1.	Short title
3		This is the Western Australian Photo Card Act 2013.
4	2.	Commencement
5		This Act comes into operation as follows —
6 7		(a) sections 1 and 2 — on the day on which this Act receives the Royal Assent;
8 9		(b) the rest of the Act — on a day fixed by proclamation, and different days may be fixed for different provisions.
10	3.	Terms used
11		In this Act, unless the contrary intention appears —
12 13		<i>applicant</i> means a person who makes an application under section 5;
14 15		<i>cardholder</i> , in relation to a photo card, means the person to whom the card is issued;
16		CEO means the chief executive officer of the Department;
17 18		Commissioner of Police means the person holding or acting in the office of Commissioner of Police under the <i>Police Act 1892</i> ;
19 20		Department means the department of the Public Service principally assisting in the administration of this Act;
21		destroyed includes damaged so as to be unusable;
22		disclose includes to provide, to release and to give access to;
23 24		<i>eligible person</i> means a person who is eligible under section 4 for the issue of a Western Australian Photo Card;
25 26		<i>expiry day</i> , in relation to a photo card, means the last day of the period for which the photo card is current;
27 28		photo card means a Western Australian Photo Card issued to a cardholder by the CEO under this Act and includes, where

l 2	relevant, any replacement or additional card issued to that cardholder in accordance with the regulations;
3	photo card information means information about photo cards,
1	including the information referred to in section 13(1), but does
5	not include photographs and signatures provided to the CEO
6	under this Act;
7	photograph includes a negative or an image stored
3	electronically;
9	<i>prescribed</i> means prescribed by the regulations.

1		Part 2 — Western Australian Photo Card
2	4.	Eligibility for photo card
3		A person is eligible for the issue of a Western Australian Photo Card if the person —
5		(a) is ordinarily resident in the State; and
6		(b) has reached 16 years of age; and

7 8		(c) meets any other requirements prescribed for the purposes of this section.
9	5.	Application for photo card
10 11	(1)	A person may apply in writing to the CEO for the issue of a Western Australian Photo Card.
12	(2)	The application must be made in a form approved by the CEO.
13	(3)	The application must be accompanied by —
14 15 16		(a) such evidence as the CEO requires to satisfy the CEO of the applicant's eligibility, identity and residential address; and
17 18		(b) where relevant, a photograph and a signature in accordance with section 6; and
19		(c) the prescribed fee.
20 21 22	(4)	A person who holds a photo card (the <i>current card</i>) cannot make an application under subsection (1) for a new photo card earlier than 6 months before the expiry day of the current card.
23 24 25	(5)	Subsection (4) does not apply to an application for a replacement or additional card issued in accordance with the regulations.
26	6.	Provision of photograph and signature
27 28	(1)	An applicant must provide to the CEO, for use on the photo card —

unless subsection (3) applies, a photograph of the

applicant; and

1		(b) unless subsection (4) applies, the applicant's signature.
2	(2)	The photograph and signature are to be provided in a manner and form approved by the CEO.
4 5 6 7	(3)	An applicant does not have to provide a photograph under subsection (1) if, within the period of 10 years before the application, the applicant has provided a photograph under this Act.
8	(4)	An applicant does not have to provide a signature under subsection (1) if —
10 11		(a) the person is unable to sign because of a permanent disability; or
12 13		(b) within the period of 10 years before the application, the applicant has provided a signature under this Act.
14	7.	Issue of photo card
15 16		The CEO may issue a Western Australian Photo Card to an applicant if —
17 18		(a) the CEO is satisfied that the applicant is an eligible person; and
19		(b) the applicant has —
20 21		(i) provided the evidence referred to in section 5(3)(a); and
22 23		(ii) complied with section 6 in relation to the provision of a photograph and signature; and
24		(iii) paid the fee referred to in section 5(3)(c).
25	8.	Form and content of photo card
26	(1)	A photo card must be in a form approved by the CEO.
27 28 29	(2)	A photo card must contain the following — (a) the cardholder's photograph; (b) the cardholder's name;

1		(c) the cardholder's date of birth;
2		(d) if the cardholder so chooses, the cardholder's residential address;
4 5		(e) the cardholder's signature, unless section 6(4)(a) applies;
6		(f) the expiry day of the card.
7	9.	Duration of photo card
8 9		A photo card is current for the period prescribed, or provided for, by the regulations.
10	10.	Cancellation of photo card
11 12	(1)	The CEO may, by written notice given to the cardholder, cancel a photo card —
13 14		(a) if the CEO considers that the cardholder is no longer an eligible person; or
15 16 17 18		(b) if the CEO considers that the cardholder obtained the photo card on the basis of incorrect or misleading information (whether or not fraud or misrepresentation was involved) or in a manner contrary to this Act; or
19 20		(c) if the cardholder obtained the photo card by means of a form of payment that was subsequently dishonoured; or
21		(d) on such other grounds (if any) as are prescribed.
22 23 24 25	(2)	If a photo card is cancelled under subsection (1), the CEO may, by the notice referred to in subsection (1) or by subsequent written notice given to the cardholder, direct the cardholder, within the period specified in the notice —
26 27		(a) to return the photo card to the CEO in the manner specified in the notice; or
28 29		(b) to notify the CEO in writing that the photo card has been stolen, lost or destroyed.
30 31	(3)	A person must comply with a direction given under subsection (2).
32		Penalty: a fine of \$2 500.

11.	Other	offences	relating	to	photo	cards

- A person must not give information that the person knows to be (1) 2 false or misleading in a material particular to a person 3 performing a function under this Act. 4
- (2) A person must not forge or fraudulently alter a photo card. 5
- A person must not use a forged or fraudulently altered photo (3) 6 card, or a photo card to which the person is not entitled. 7
- A person must not, without lawful excuse, have in the person's (4) 8 possession with intent to deceive, a photo card, or an article 9 resembling a photo card. 10
- A person must not lend a photo card to, or allow a photo card to (5) 11 be used by, another person. 12
- Penalty for an offence under this section: a fine of \$2 500. 13

18 19 20 21 22 23	(4)	The CEO may, with the prior approval of the Commissioner of Police, disclose photographs to a law enforcement official if the CEO considers that the photographs are required for the purposes of the performance of the law enforcement official's functions under a written law or a law of the Commonwealth, another State or a Territory.
24	16.	Disclosure of photographs to executor or administrator
25		If the person shown in a photograph has died, the CEO may
26		disclose the photograph to an executor or administrator of the
27		person's estate.

1 2	17.	Photographs and signatures: possession, reproduction and destruction
3 4 5	(1)	The CEO must ensure that a photograph or signature is destroyed if it, or a copy of it, has not been used on a photo card issued in the preceding 10 years.
6 7 8	(2)	A person must not, other than for the purposes of this Act, possess a photograph or signature that is not on a photo card. Penalty: imprisonment for 2 years.
9	(3)	Subsection (2) does not apply to a person who possesses a photograph as a result of its disclosure under section 15 or 16.
1 2 3 4	(4)	A person employed or engaged in connection with any aspect of the production of photo cards or otherwise concerned in the administration of this Act must not, other than for the purposes of this Act —
5		(a) reproduce, by any means, a photograph or signature; or(b) cause or permit another person to do so.

27 28 29		(c) a person who is employed in the department of the Public Service principally assisting in the administration of the <i>Police Act 1892</i> .		

1	(2)	The delegation must be in writing signed by the Commissioner of Police.			
3	(3)	A person to whom a power or duty is delegated under this section cannot delegate that power or duty.			
5 6 7 8	(4)	A person exercising or performing a power or duty that has been delegated to the person under this section, is to be taken to do so in accordance with the terms of the delegation unless the contrary is shown.			
9 10	(5)	Nothing in this section limits the ability of the Commissioner of Police to perform a function through an officer or agent.			
11	20.	Agreements for performance of functions			
12 13 14	(1)	The CEO may enter into an agreement providing for the CEO's functions under this Act that are described in the agreement to be performed on behalf of the CEO.			
15 16 17	(2)	The agreement may be with the Commissioner of Police, a local government, or any other person or body, whether or not the person or body has itself functions of a public nature.			
18 19 20	(3)	A function described in the agreement may be performed — (a) in accordance with the agreement; and (b) on and subject to terms and conditions in the agreement.			
21 22 23 24 25	(4)	If the performance of a function is dependent upon the opinion, belief, or state of mind of the CEO it may be performed under the agreement upon the opinion, belief, or state of mind of the person or body with whom the agreement is made or another person provided for in the agreement.			
26 27 28 29	(5)	The CEO may disclose photo card information to the person or body with whom the agreement is made if the CEO considers that the information is required for the purposes of performing a function under the agreement.			
30 31	(6)	For the purposes of this Act or any other written law, an act or thing done by, to, by reference to, or in relation to, a person or
