4663. Mr J.N. Hyde to the Minister for Heritage

In relation to the former Minister's media statement on 19 November 2010, that staff from the State Records Office (SRO) were assisting the Town of Claremont after fire destroyed town records and that the SRO holds records of the Town, I ask:

- (a) will the Minister confirm if the Town of Claremont had current, best practice disaster recovery and business continuity plans at the time of the fire; and
 - (i) if yes, will the Minister table these plans in Parliament;
- (b) what inventory or index existed of historical records held by the Town of Claremont at the time of the fire; and
- (c) will the Minister advise, by series or item title, what historical records have been lost as a consequence of the fire of 18 November 2010?

4664. Mr R.H. Cook to the Minister representing the Minister for Mental Health

- (i) does the Minister concede that parking is likely to be more expensive and less accessible for staff, patients and visitors alike at the QEII site compared to Bentley?
