# WEDNESDAY, 21 JUNE 2017

### 1. Meeting of Assembly

The Assembly met at 12 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

### 2. Death of Peter Jones AM – a former Member of the Legislative Assembly

The Premier, without notice, moved,

That the House records its sincere regret at the death of Peter Jones AM and tenders its deep sympathy to his family.

The motion was supported by Dr M.D. Nahan, Ms M.J. Davies, Mr W.R. Marmion and Mr P.J Rundle.

Question put and passed unanimously with members and officers of the Assembly standing in their places as a mark of respect.

### 3. Petition

Somerville Drive and Bussell Highway intersection – Mr D.T. Punch presented a petition from 185 people asking the Legislative Assembly to instruct Main Roads to reduce the speed limit from 80 kmh to 60 kmh from the Bunbury Regional Hospital campus exit/entry point on Bussell Highway to a point 200 metres south of Somerville Drive on both carriageways, in the interest of safety (P. 9).

- (a) notes with concern the anomalies in enrolments in the district of Pilbara in the 2017 State Election;
- (b) expresses concern at the unprecedented and significant campaign activities of the Chamber of Minerals and Energy Western Australia;
- (c) notes the McGowan Government's intention to conduct an inquiry into third party fundraising bodies;
- (d) notes with concern that Parliament has no standing committee specifically tasked with oversight of electoral laws and practices in line with other jurisdictions including New South Wales and Victoria.

Debate ensued.

The Minister for Electoral Affairs was granted leave to continue his remarks at a later stage of the sitting.

# 14. Financial Planning

Dr M.D. Nahan, pursuant to notice, moved,

That this House condemns the McGowan Government for not having a credible financial plan to pay for \$5 billion of unaffordable election promises and now forcing households to pay for them through new taxes, increases in fees and charges and cuts to frontline services.

Debate ensued.

Debate interrupted by the Chair (Minister for Mines and Petroleum speaking) and adjourned until a later stage of the sitting.

The Leader of the House moved, That the House do now adjourn.
