1. Meeting of Assembly

That the House condemns the Barnett Government for creating 141 new committees and reviews in its first ten and a half months in office at a cost of \$7 million while at the same time cutting support for needy Western Australians.

19. National Gas Access (WA) Bill 2008

The Legislative Council acquaints the Legislative Assembly that it has agreed to the *National Gas Access (WA) Bill 2008* subject to the amendments contained in the Schedule annexed; in which amendments the Legislative Council desires the concurrence of the Legislative Assembly.

Schedule indicating the amendments made by the Legislative Council in the National Gas Access (WA) Bill 2008.

No. 1

Page 16, after line 10 — To insert —

(1A) The national provisions do not affect the continuance or operation of an exempt contract.

No. 2

Page 16, line 12 — To insert after "apply" —

to a contract other than an exempt contract

No. 3

Page 16, lines 16 to 20 — To delete the lines and insert —

exempt contract —

(a) means a contract in respect of which a declaration under the *Gas Corporation Act 1994* Schedule 5 clause 6 was in force immediately before the coming into operation of the *Dampier to Bunbury Pipeline Act 1997* Schedule 4 clause 17(4); and

- (b) includes a contract entered into
 - (i) in substitution for a contract referred to in paragraph (a) or any provision of such a contract; or
 - (ii) by way of amendment of a contract referred to in paragraph (a) or subparagraph (i);

national provisions means the National Gas Access (Western Australia) Law, the Rules made under that Law, and the National Gas Access (Western Australia) Regulations;

relevant national provisions means any of the national provisions having the same purpose as a provision of the Gas Code, as defined in the National Gas Access (Western Australia) Law section 2.

No. 4

Page 18, line 10 — To delete "a review to be carried out" and insert —

a person, other than an officer of a department or body for which the Minister is responsible, to carry out a review

No. 5

Page 18, after line 26 — To insert —

(2A) The person carrying out the review is to prepare and give to the Minister a report based on the review within sufficient time to enable the Minister to comply with subsection (3).

No. 6

Page 18, lines 27 to 31 — To delete the lines and insert —

(3) The Minister is to prepare a response to the report and, as soon as is practicable after the response is prepared, and in any event not more than 12 months after the review day described in subsection (2), cause the report and the response to be laid before each House of Parliament.
