## 1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

#### 2. Death of Claude Stanley Choules

The Premier, without notice, moved,

That this House records its sincere regret at the death of Claude Stanley Choules and tenders its deep sympathy to his family.
