- (c) what are the titles of the personnel in Synergy who approved the use of *The Simpsons* animation?

  - (b) 2017-2018 to date?
- (2) In relation to each of those years, what is the gender breakdown and how many of these were:

- (c) between the age of 27 and 45; and
- (d) over the age of 45?
