6. Suspension of Standing Orders – Statements in Relation to the Centenary of Armistice

That so much of the Standing Orders be suspended as is necessary to enable at 11.00 am on Thursday, 8 November 2018 the House to observe one minute's silence in recognition of the Centenary of Armistice, and to be followed by the Premier, the Leader of the Opposition and the Leader of the National Party, or a member deputed, to make statements up to a maximum of 15 minutes each commemorating the centenary of the Armistice that ended the First World War, and then any other member to be able to make statements in reply, up to a maximum of 5 minutes each, and for these statements to have priority until 12.50 pm, unless concluded earlier, or if not concluded at 12.50 pm, to continue after Question Time until concluded.

7. Animal Welfare Amendment Bill 2017

That a bill for “An Act to amend the *Animal Welfare Act 2002*.” be introduced and read a first time.

8. Gender Reassignment Amendment Bill 2018
