#### 1472. Hon Neil Thomson to the Minister for Finance; Commerce; Women's Interests:

I refer to the cost and application process for obtaining and/or renewing a Class 2 Demolition License in the State of Western Australia. In table form, for each of the following years – 2016; 2019; 2021; 2023 please advise the following:

- (a) the application cost of obtaining & Demolition License;
- (b) how many FTE positions are/were allocated to assessing and approving these applications; and
