TUESDAY, 30 AUGUST 2011

1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Speaker's Statement – Statewide Student Parliament

The Speaker welcomed to the public gallery 97 Year 10 students representing every Legislative Assembly district and every Legislative Council Region who had participated in the Statewide Student Parliament that had taken place the day before in both the Assembly and the Council chambers.

3. Brief Ministerial Statements

Brief Ministerial Statements were made by -

The Minister for Corrective Services on the Perth horse trial event held at the Wooroloo prison farm.

The Minister for Local Government on the approval of land for a new cemetery at Whitby Falls.

The Minister for Lands on the implementation of initiatives by Landgate to reduce fraudulent land transactions.

6. Petitions

Albany PCYC – Mr P.B. Watson presented a petition from 61 persons requesting that the Legislative Assembly commit to ensuring that sworn police officers continue to manage the Albany PCYC and that their ongoing role is secure (P. 456).

First Choice Liquor Superstore Maylands – Ms L.L. Baker presented a petition from 604 persons requesting that the Legislative Assembly ensure that Liquorland is not granted a liquor licence for the proposed First Choice Liquor Superstore in Maylands and also that it investigate the potential of heavily discounted liquor sold by these types of stores to influence violence in the community (P. 457).

Bus Services in the Shire of Murray – Mr M.J. Cowper presented a petition from 58 persons requesting that the Legislative Assembly support their campaign for the Government to provide a regular bus service between Pinjarra and Mandurah (P. 458).

10. Community Development and Justice Standing Committee – Terms of Reference

The Speaker advised members that he had received a letter dated 19 August 2011 from the Chair of the Community Development and Justice Standing Committee advising that the Committee at its meeting on 17 August 2011 had resolved to conduct an Inquiry with the following terms of reference:

With a focus on State Government workers and volunteers who work with, or under the supervision of, State Government agencies which are involved in emergency responses, the Committee will examine:

- whether existing agency responses adequately address the trauma experienced by staff and volunteers during and after declared natural or other disasters which have occurred since 2001;
- the barriers to those suffering trauma from accessing available assistance services; and
- the measures to mitigate any health impacts from trauma to those State Government workers and volunteers who responded to a declared disaster.

The Committee will report by 1 December 2012.

11. Matter of Public Interest – Minister for Emergency Services – Management of Last Bushfire Season

The Speaker informed the Assembly that he was in receipt of a notice from Mr E.S. Ripper that he intended to move a motion on a matter of public interest.

At least five members having risen in support,

Mr E.S. Ripper moved,

That the House calls upon the Minister for Emergency Services to explain to the House his personal involvement in the following issues:

- FESA's poor preparation for the last bushfire season;
- the management debacle on the day of the Roleystone-Kelmscott bushfires;
- the FESA cover-up during the Keelty Special Inquiry; and
- outline why he thinks he should retain the Emergency Services portfolio.

Debate ensued.

Question put and passed.

12. Ministerial Response – Management of Last Bushfire Season

The Minister for Emergency Services responded to the foregoing Matter of Public Interest on management of the last bushfire season.

13. Suspension of Standing Orders

Mr M. McGowan, without notice, moved, That so much of the Standing Orders be suspended as is necessary to enable the following motion to be moved forthwith -

That the Premier explain whether or not the Minister for Emergency Services has his confidence and for how long will he keep that portfolio.

Debate ensued.

Message No. 172 dated 18 August 2011 from the Legislative Council was reported forwarding for concurrence a bill for "An Act to adopt the *Personal Property Securities Act 2009* (Commonwealth) as amended by the *Personal Property Securities (Consequential Amendments) Act 2009* (Commonwealth), the *Personal Property Securities (Corporations and Other Amendments) Act 2010* (Commonwealth) and the *Personal Property Securities (Corporations and Other Amendments) Act 2011*, to refer certain matters relating to security interests in personal property to the Parliament of the Commonwealth, for the purposes of section 51(xxxvii) of the Constitution of the Commonwealth, and to enact consequential provisions."

, unless earlier lawfully terminated by either party to the contract, that person becomes a staff member of the Authority and is to be taken to have been employed under the contract of service under section 109(2), and without loss of conditions and entitlements held at the coming into operation of this subsection.

On the question, That the words be deleted,

Amendment put and negatived.

Clause agreed to.

Clauses 151 to 155 agreed to.

Title agreed to.

Consideration in detail concluded.

Ordered, That the third reading of the bill be made an Order of the Day for the next sitting of the Assembly.

Bill read a third time and forwarded to the Legislative Council for concurrence.

Message No. 174 dated 30 August 2011 from the Legislative Council was reported forwarding for concurrence a bill for "An Act to amend the *Inheritance (Family and Dependants Provision) Act 1972* and other Acts, and for related purposes.

Ordered, That the first reading of the bill be made an Order of the Day for the next sitting of the Assembly.

22. Residential Tenancies Amendment Bill 2011

The Order of the Day for the resumption of the debate upon the second reading of the bill was read. Debate resumed.
