1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

An Acknowledgement of Country and Prayers were read.

2. Petitions

Fracking in the Shire of Gingin – Mr R.S. Love presented a petition from 364 people asking the Legislative Assembly to ban fracking in the Gingin Shire (P. 188).

Road signage in regional Western Australia – Mr V.A. Catania presented a petition from 403 people asking the Legislative Assembly to examine a range of road signage safety concerns, particularly in regional and remote WA, by way of a bi-partisan parliamentary committee (P. 189).

The Minister for Seniors and Ageing on the introduction of a mandatory Code of Practice for Western Australia's prepaid funeral industry.

The Minister for Racing and Gaming on a \$16 million increase in funding to the racing industry for the 2020–21 season.

The Minister for Fisheries on the rollout of the Beach Emergency Number signs and funding for helicopter patrols of beaches as part of the Government's shark mitigation strategy.

The Minister for Women's Interests on women in the Senior Executive Service in the public sector.

13. G2G Pass Approval Process

Mr P.A. Katsambanis, pursuant to notice, moved,

That this House notes that the lack of transparency and consistency of the G2G Pass approval process has caused significant stress, anxiety and distress to Western Australians who are trying to legally return home; and calls on the government to create a clearer, simpler and more consistent process to allow local residents to return to Western Australia whilst continuing to protect our State from COVID-19.

Debate ensued.

Debate interrupted by the Chair (Minister for Police speaking) and adjourned until a later stage of the sitting.
