    - (i) if not, why not; and
  - (e) how many inmates perform kitchen or cooking duties?
- (2) For the 2017-2018 financial year, how much money is dedicated for the procurement of kitchen equipment at the prison?
- (3) For the 2016-2017 financial year, how much money was spent on the procurement of kitchen equipment at the prison?
