- (d) has the PPA received any briefings, information or emails from Western Australia Police on any matter related to or within the local government district of Bayswater and if so, what was the specific nature of the briefings; and
- (e) has the Public Sector Commissioner (PSC) been informed of the PPA's candidacy, and:
  - (i) if so, what was the response of the of the PSC; and
  - (ii) if not, why not?
