- (b) current rehabilitative programs and strategies in Western Australian prisons;
- (c) the impact of prison education and training programs on post-release outcomes and the data collection capacity within government to evaluate the effectiveness of existing programs;
- (d) the gaps in post-release outcomes between Aboriginal and non-Aboriginal offenders;
- (e) the legislative and community incentives and impediments to prisoner employment, education and training;
- (f) the integration of behaviour management, education and training strategies with real work opportunities;
- (g) the success of alternative strategies, nationally and internationally in reducing recidivism; and
- (h) any major issue that emerges that the Committee considers should be included in the inquiry.
