I refer to the answer to Question on Notice No 3417 (c), and ask what is the current value of the Frederick McCubbin painting *Down on his luck* currently in the Art Gallery of WA collection?

3981. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the answer to Question on Notice No 3417 (h)(i), and ask:

- (a) Is there a timeline to repair the 9 paintings in the Art Gallery of WA collection identified as “Unstable-requires immediate attention”;
- (b) Is there funding for the repairs of the 9 paintings;
- (c) How much will it cost to repair the 9 paintings;
- (d) When was each of the 9 paintings purchased;
- (e) For how much was each of the 9 paintings purchased;
- (f) What is the current value of the 9 paintings; and
- (g) Please list the 9 paintings?

3982. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the answer to Question on Notice No 3415 (1)(c) and a radio frequency identification (RFID) tracking system to be implemented in the Art Gallery of WA artworks collection, and ask:

- (a) What is the start-up costs to implement the RFID system;
- (b) What will be the ongoing costs for the RFID system in each of the years 2019-20 and 2020-21; and
- (c) Which company has supplied the RFID system and where is the business located?

3983. Mr A. Krsticevic to the Minister for Culture and the Arts:

- (e) How has the survey helped to increase patronage at the Art Gallery of WA?

3984. Mr A. Krsticevic to the Minister for Local Government; Heritage; Culture and the Arts:

I refer to the answer to Question on Notice No 3409, and ask has the Minister taken steps to reduce the level of unauthorised credit card use in each department considering the practice has increased in each of the past three years, and if yes:

- (a) What measures did the Minister take to address the unauthorised use of credit cards; and
- (b) Have any credit cards been withdrawn because of unauthorised use:
 - (i) When were they withdrawn;
 - (ii) From which departments were the credit cards withdrawn; and
 - (iii) Why were they withdrawn?

3985. Mr A. Krsticevic to the Minister for Local Government:

I refer to the answer to Question on Notice No 3406 (c) and ask of the six local governments with a passable assessment in 2017 has the Department made further enquiries to determine if improvements have been made, and if yes:

- (a) Which local governments were checked and when;
- (b) Which local governments had taken steps to improve governance; and
- (c) If not, why not?

3986. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Ministers answer to Question on Notice No 3401 (c), and ask:

- (a) Why was the officer seconded to the State Records Office not retained beyond June 2018; and
- (b) Will the withdrawal of the seconded officer be reconsidered for 2018-19 year?

3987. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Ministers answer to Question on Notice No 3399 (c), and ask when will the business case considering funding for State Archives access be finalised and how long will it take after finalising the business case for the funding to be available?

3988. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Ministers answer to Question on Notice No 3398 (c), and ask of the 114 Art Gallery of WA works of art stored at an offsite storage facility:

- (a) How much floor space at the facility do the 114 artworks take up;
- (b) How many of the 114 artworks have been stored at the offsite facility for the more than three years; and
- (c) Are any of the 114 artworks stored at the offsite facility scheduled to be on display in the next 12 months?

3989. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Ministers answer to Question on Notice No 3323 (b)(c), and ask of the individuals that participated in topic forums held in July to prepare discussion papers for phase two of the Local Government Act Review:

- (a) How many participated via Skype or telephone;
- (b) How many responded via email; and
- (c) How many individuals from regional areas participated via Skype, telephone or email?

3990. Mr P.A. Katsambanis to the Minister for Police; Road Safety:

I refer to the Police Regional Enforcement Unit (REU), and ask:

- (a) Since REUs commenced patrols on 15 January 2018 how many breath tests have been conducted as of 1 August 2018;
- (b) Since REUs commenced patrols on 15 January 2018 how many speeding infringement notices for speeding have been issued;
- (c) How many of the additional 25 Police Officers have been recruited as of 1 August 2018; and
- (d) From 15 January to 1 August 2018 what is the breakdown (per regional policing districts) for breath tests and issued speeding infringement notices?
