- (a) what has happened to the review of the Act:
 - (i) what were the recommendations from the review; and
 - (ii) when will the details of the review be made public;
- (b) is the Minister planning new legislation to replace or amend the current Act;
- (c) why has there not been a Caravan Parks and Camping Grounds advisory committee, as required under the Act, since 30 June 2010;

- (d) why hasn't there been a meeting of the Caravan Parks and Camping Grounds advisory committee since 28 October 2009;
- (e) who is making recommendations to the Department of Local Government, Sport and Cultural Industries regarding issues to do with the Act, caravan parks and camping grounds;
- (f) does the Minister and his department recognise that an active advisory committee is required under the Act; and
- (g) when will the Caravan Parks and Camping Grounds advisory committee be reinstated?

4334. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Control of Vehicles (Off-road Areas) Act 1978, and ask:

- (a) why hasn't there been a meeting of the *Control of Vehicles (Off-road Areas) Act 1978* advisory committee since 30 November 2016;
- (b) when was the last time the advisory committee made a recommendation to the Minister or his department regarding control of vehicles in off-road areas:
 - (i) will the Minister table the most recent correspondence from the advisory committee;
- (c) what other groups have been providing advice to the Minister or his department regarding the use of vehicles in off-road areas:
 - (i) what was their advice or recommendations; and
- (d) when will the Minister make a decision on the composition of a new advisory committee?

4335. Mr A. Krsticevic to the Minister for Local Government:

I refer to the statement in the Department of Local Government and Cultural Industries 2017-18 Annual Report, and ask:

- (a) what is the Off-Road Vehicles project mentioned on page 64;
- (b) what are the functions of the Off-Road Vehicles project;
- (c) who works on the Off-Road Vehicles project;
- (d) where does the funding for the Off-Road Vehicles project come from:
 - (i) please provide a breakdown of the funding and the amounts of each grant;
- (e) how much funding has the Off-Road Vehicles project received in each of the years 2014-15, 2015-16 and 2016-17:
 - (i) please provide a breakdown of the funding for each year; and
- (f) for each of the years 2014-15, 2015-16, 2016-17, 2017-18 where was the funding for the Off-Road Vehicles project spent?

4336. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the answer to Question on Notice No. 3971 that the \$32.4 million in savings from the new WA Museum budget has not been re-allocated within the Culture and the Arts portfolio, and ask:

- (a) why not;
- (b) why was some of the money not used to fund the renovations to His Majesty's Theatre instead of new monies being sourced;
- (c) is there an updated final cost of construction of the new WA Museum:
 - (i) if yes, what is the updated cost;
- (d) when will the new WA Museum be completed; and

(e) is there a date for the opening of the new WA Museum and, if yes, what is it?

4337. Mr A. Krsticevic to the Minister for Culture and the Arts:

On page 21 of the Department of Local Government, Sport and Cultural Industries 2017-18 Annual Report it is stated \$344,145 in funding was provided to nine projects via the Local Projects, Local Jobs program, and I ask:

- (a) can the Minister please provide a breakdown of the projects and how much funding each received:
 - (i) when were each of the grants made;
- (b) do any of the projects receive other grants from the department or its agencies:
 - (i) if yes, please provide a breakdown of each grant, the programs, the total of monies contributed and the dates they were made; and
- (c) what was the percentage of the nine grants in terms of grants made in total to the overall Local Project, Local Jobs program for the 2017-18 year?

4338. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the number of paid attendances to funded organisations works listed in the Department of Local Government, Sport and Cultural Industries 2017-18 Annual Report, and ask:

- (a) how many complimentary tickets were distributed for the funded works presented and/or developed in 2017-18:
 - (i) what was the total value of the complimentary tickets and who were they given to;
- (b) how many complimentary tickets were distributed for funded works presented and/or developed in each of the years 2014-15, 2015-16 and 2016-17:
 - (i) what was the total value of the complimentary tickets for each of the years; and
- (c) who conducts the Arts and Culture Monitor Survey which reflects the public value of funded works and events:
 - (i) what was the cost of conducting the survey for each of the years 2014-15, 2015-16, 2016-17 and 2017-18?

4339. Mr A. Krsticevic to the Minister for Culture and the Arts:

Has the Minister, his Ministerial staff or department staff received any complaints or grievances relating to bullying by managers associated with the Art Gallery of WA, and:

- (a) if yes, how many complaints or grievances:
 - (i) when were complaints or grievances lodged; and
 - (ii) what were the bullying behaviours reported in the complaints or grievances;
- (b) has there been any training on how to prevent bullying for managers at the Art Gallery of WA:
 - (i) if yes, on what dates; and
 - (ii) did any Art Gallery of WA managers not attend the training sessions and list how many;
- (c) how many complaints or grievances required action to be taken:
 - (i) please list all actions taken and the dates on which the action occurred;
- (d) has WorkSafe investigated any claims of workplace bullying in the Art Gallery of WA:
 - (i) if yes, what were the outcomes of the WorkSafe investigations; and

- (e) were any complaints or grievances referred to the Corruption and Crime Commission or Public Sector Commission:
 - (i) if yes, how many and please list the dates they were referred;
 - (ii) was the Minister or any department staff advised of the outcomes of the referrals and on what dates were they advised; and
 - (iii) what were the outcomes of the referred complaints or grievances?

4340. Mr A. Krsticevic to the Minister for Culture and the Arts:

Can the Minister please provide a breakdown of State Government funding provided to Screenwest for the 2017-18 year, and:

- (a) was the funding to be directed to specific programs:
 - (i) please provide a breakdown as to how much funding was dedicated to which programs; and
 - (ii) what was the economic benefit from the State Government funding;
- (b) has the Minister or any members of his department expressed concern to Screenwest that it has yet to publish its 2017-18 Annual Report; and
- (c) what actions have been taken to make sure an annual report is lodged as a matter of urgency?

4341. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the announcement by the Premier and the Minister on April 30 that the State Government would allocate \$3 million to a Contemporary Music Fund, and ask:

- (a) why, six months later, have no applications been received for the grants as per the Minister's response on 9 October 2018 to Question on Notice No. 3973;
- (b) why do references to the Contemporary Music Fund on the Department's Culture and the Arts website only link to the Minister's Media Statement from 30 April and not to the application process;
- (c) why is the application process not on display on the department website for public viewing; and
- (d) what will happen to the \$500,000 provided in this year's State Budget for the Contemporary Music Fund if no grants are made?

4342. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Department of Local Government, Sport and Cultural Industries 2017-18 Annual Report that identifies process weaknesses resulting in the inability to list the cost per service for the State Records Office, and ask:

- (a) is this a result of resource limitations within the State Records Office (SRO);
- (b) do resource limitations present a risk to the SRO's ability to provide information management and archival services;
- (c) what is the Minister and/or his department doing to fix the resources problem in the State Records Office:
 - (i) please list the measures; and
- (d) by failing to report the State Records Office Efficiency Indicator is the department non-compliant with the Under Treasurer's requirements as per the Auditor General's statement:
 - (i) what actions has the Minister, his ministerial staff or department staff taken to correct the situation?

4343. Mr P.A. Katsambanis to the Minister for Transport; Planning; Lands:

I refer to Transport Inspectors, and ask:

- (a) how many transport inspectors did Main Roads WA have for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (b) how many transport inspectors did the Department of Transport have for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (c) how many transport inspectors did the Public Transport Authority have for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (d) how many transport inspector positions were approved for 2018;
- (e) how many transport inspectors were recruited in 2016, 2017 and as of 24 October 2018;
- (f) how many transport inspectors took up the Government's Voluntary Targeted Separation Scheme;
- (g) how many transport inspectors left Main Roads WA or the Department of Transport and went to other government departments or agencies in 2016, 2017 and as of 24 October 2018;
- (h) how many infringement notices for non-compliance did transport inspectors issue for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (i) how many infringement notices for non-compliance did transport inspectors issue in regional Western Australia for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (j) how many infringement notices for non-compliance did transport inspectors issue in metropolitan Western Australia for each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018;
- (k) how many transport inspectors are there for each regional development commission boundary in Western Australia as of 24 October 2018;
- (l) how many transport inspectors were there for each regional development commission boundary in Western Australia for the years 2013, 2014, 2015, 2016 and 2017;
- (m) do any transport inspectors occupy Government Regional Officer Housing;
- (n) if yes to (m), how many and where;
- (o) how many Haenni WL101 load scales do Main Roads and/or the Department of Transport have;
- (p) what is the cost of a Haenni WL101 load scale;
- (q) in the last five years how often were the Haenni WL101 load scales audited and calibrated; and
- (r) how many roadblocks in regional WA did transport inspectors conduct in each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018?

4344. Mr P.A. Katsambanis to the Minister for Police; Road Safety:

I refer to the Western Australian Cricket Association's International Fixtures in 2018, and ask:

- (a) how many Western Australian Police Force officers will be deployed for the Australia v South Africa one day international match on 4 November 2018;
- (b) how many Western Australian Police Force officers will be deployed for the Australia v India test match running from 14 December 2018;
- (c) has the Western Australia Police Force met with, and provided advice to, the ground operators of these two matches on security and risk level;

- (d) has an emergency response plan been prepared by the Western Australian Police Force in conjunction with the venue operator for these two fixtures; and
- (e) has a terrorism threat assessment has been conducted either as part of the plan or otherwise?

4345. Mr P.A. Katsambanis to the Minister for Police; Road Safety:

I refer to the Western Australian Police Force and Government Public Sector, and ask:

(a) what was the number of public servants who transferred out of the Western Australian Police Force to another government department or agency in each of the years 2013, 2014, 2015, 2016, 2017 and as of 24 October 2018?

4346. Mr P.A. Katsambanis to the Minister for Police; Road Safety:

I refer the Minister to veterans and ex-Australian Defence Force (ADF) personnel in the Western Australian Police Force, and ask:

- (a) for statistical purposes does WA Police record a recruits previous service in the ADF;
- (b) if yes to the above, how many veterans or ex-ADF personnel are currently serving in WA Police;
- (c) does WA Police have a recruiting strategy to attract veterans or ex-ADF personnel exiting the military;
- (d) are the trade qualifications or other nationally accredited qualifications attained whilst in the ADF taken into consideration during recruitment by WA Police; and
- (e) how many WA Police Officers are also in the Reserves of the Australian Defence Force?

4347. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Department of Local Government, Sport and Cultural Industries 2017-18 Annual Report and the statement that only 38 per cent of councils had planning and reporting plans reviewed despite a target of 100 per cent, and ask:

- (a) is the low number of reviews due to resourcing impacts following Machinery of Government changes as stated in the report;
- (b) have any local governments expressed concern to the department that their planning and reporting plans weren't reviewed:
 - (i) if yes, please list the local governments;
- (c) what is the Minister and/or his department doing to rectify the problem of insufficient resources in the review area:
 - (i) please list the measures; and
- (d) considering the report stated 71 per cent of local governments had action taken against them for non-compliance in 2017-18 are there sufficient resources in the department to ensure councils are operating correctly under the *Local Government Act 1995* and its regulations:
 - (i) if yes, how?

4348. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the chief executive and principle executive officers of the State Library of WA, WA Museum and Art Gallery of WA, and ask:

(a) for each of the years 2015-16, 2016-17, 2017-18 and from 1 July to 20 October 2018 how many days was each officer absent from WA on interstate or overseas work duties;

- (b) what percentage of their working days, excluding leave and sickness days, did this represent for each officer in each year;
- (c) what were the destinations and duration of stays for each official visit:
 - (i) what were the costs of each visit and the total cost for each of the years;
- (d) what were the reasons for each of the trips;
- (e) were any adjoining holiday excursions made in association with any of the work trips:
 - (i) if yes, what holiday trips were undertaken, by whom, when and to where; and
 - (ii) what contribution did any of the officers make to the trips that involved a personal holiday component and please provide a breakdown of the contributions; and
- (f) did any of the officers conduct third-party work during any of the interstate or overseas trips:
 - (i) please list the third-party work and which officers conducted them; and
 - (ii) in each case who approved the third-party works?

4349. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA and ask how many acts of anti-social behaviour inside and outside of the building were reported for each of the years 2016-17 and 2017-18, and:

- (a) on how many occasions in each year were police called to help with anti-social incidents:
 - (i) please list the occasions;
- (b) what measures have been taken to protect staff and visitors from anti-social behaviour at the library; and
- (c) has any more funding been provided to the library for increased security measures:
 - (i) if yes, please provide details of the extra funding?

4350. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the \$20 million roof top bar and entertainment area planned for the Art Gallery of WA, and ask:

- (a) have two American artists been commissioned to deliver works for the new facility:
 - (i) if yes, please list the names of the American artists; and
 - (ii) please list the artworks those artists will provide for the facility and the costs for each;
- (b) have any other overseas artists been commissioned to provide artworks for the facility:
 - (i) if yes, please name the artists, their overseas location and the costs of each artwork:
- (c) will the costs of the artwork be met by the \$2.5 million grant provided by the State Government through the TomorrowFund:
 - (i) if yes, will the \$2.5 million grant cover the full cost of the artworks for the rooftop facility; and
 - (ii) if not, where will the extra funding for the artworks come from;
- (d) are any Aboriginal artists involved in the provision of artworks for the rooftop facility:
 - (i) if yes, please list the artists and the costs of each artwork;
- (e) who is choosing the artworks for the rooftop facility;

- (f) when were the decisions made regarding the provision of the artworks for the facility; and
- (g) why has there been no public consultation or competitions conducted for the provision of the artworks?
