1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Procedure and Privileges Committee

Mr M.W. Sutherland, as Deputy Speaker, presented the following report which was ordered to lie upon the Table of the House –

Procedure and Privileges Committee - Matters Arising from the Corruption and Crime Commission Report Tabled in the Legislative Assembly on 16 November 2009, Report No. 7 (1666).

Mr M.W. Sutherland spoke on the report.

3. Petitions

Inclusion of Year 7 Students in State Secondary Schools - Mr C.J. Tallentire presented a petition from 19 persons requesting that the inclusion of year 7 students in the state school sector be opposed pending consideration of how the best outcome for students can be achieved (P. 193).

Increase in Government Fees and Charges - Mr C.J. Tallentire presented a petition from 15 persons requesting that relief be given to Western Australian householders (P. 194).

Boxing Day Trading Hours - Ms M.M. Quirk presented a petition from 58 persons requesting that Boxing Day not be included in any retail trading hours deregulation (P. 195).

Shack Site Communities - Petitions requesting that Shack Site communities be preserved so Western Australians have affordable coastal holiday destinations for future generations were presented by –

Mr R.H. Cook from 422 persons (P. 196);

Mr M. McGowan on behalf of Mr D.A. Templeman from 456 persons (P. 199); and

Mr M.J. Cowper from 117 persons (P. 200).

Uranium Mining in Western Australia - Ms A.S. Carles presented a petition from 681 persons requesting that the ban on uranium mining be re-instated (P. 197).

Urban Development South of Moore River - Petitions requesting that the Legislative Assembly support the recommendation that the land adjoining the proposed Wilbinga Conservation Park be protected from future development were presented by -

Mr P.B. Watson from 20 persons (P. 198);

Dr J.M. Woollard from 20 persons (P. 201); and

Street Posting Box in Morgan Fields Estate - Ms R. Saffioti presented a petition from 73 persons requesting that a street posting box be installed in the Morgan Fields estate (P. 202).
