TUESDAY, 14 AUGUST 2012

1. Meeting of Assembly

The Assembly met at 2.00 p.m. pursuant to adjournment.

The Speaker took the Chair.

2. Brief Ministerial Statements

Newman Hospital – Mr V.A. Catania presented a petition from 245 persons requesting that the Legislative Assembly ensures that some of the money generated from local mining operations is spent on health facilities for the people of Newman (P. 626).

Livestock Animal Welfare – Ms L.L. Baker presented a petition from 127 persons requesting that the Legislative Assembly funds the employment of six permanent full-time general inspectors in the Department of Local Government's Animal Welfare Unit Inspectorate to ensure that the welfare of animals involved in live export are regularly and routinely monitored (P. 627).

Container Deposit Scheme – Mr J.C. Kobelke presented a petition from 73 persons requesting that the Legislative Assembly calls upon the Barnett Government to immediately introduce a Western Australian Container Deposit Scheme, similar to the system that operates in South Australia (P. 628).
