#### 6. Petitions

Dog Breed Regulations – Petitions requesting that the Legislative Assembly removes all legal restrictions currently on certain breeds deeming them automatically dangerous, and replaces these with a system that considers all dog breeds to be not dangerous, unless an individual investigation of the dog and owner proves the dog is a true danger to society were presented by -

Fire Fighters Compensation – Ms M.M. Quirk presented a petition from 36 persons requesting that the Legislative Assembly acknowledges that under present law a family of a fire fighter faces financial hardship where occupationally acquired cancer is contracted and ensures that laws are enacted to redress this unjust situation without further delay (P. 655).
