- (c) noting the current investigation into the City of Melville, did Mr Hilton lodge any complaints against the City, whether in his personal capacity or as part of his membership in a community group:
 - (i) if yes, please provide details of the complaint including: if it was lodged with the Department or Minister, the date it was lodged, the nature of the complaint and the issues raised; and
- (d) noting the current investigation into the City of Melville, can you provide assurance that there is no conflict of interest, perceived or otherwise, with Mr Hilton's employment in your office:
 - (i) if there is a conflict of interest, please advise what steps are being taken to manage the conflict of interest?
