- (a) is it correct that that these programs will be dropped from the GSIT program for 2013;
- (b) if so, what specific courses are to be dropped;
- (c) what is the reason GSIT have provided to drop these courses; and
- (d) will any consideration be given to continuing those courses in 2013?

## 8510.Mr B.S. Wyatt to the Premier

I refer to the comments made by the spokeswoman for the Premier on 14 August 2012 stating that the Governments advertising spend in 2010–2011 was \$24 million, and I ask:

- (a) will the Premier provide a breakdown by Government agency of the figures that add up to this \$24 million; and
- (b) will the Premier provide a breakdown by Government agency for all advertising expenditure figures for 2010–2011?

## 8511.Mr P.B. Watson to the Minister for Transport

In relation to future cycling infrastructure plans in Albany, I ask

(a) will the planning for the Albany Ring Road stages two and three also include cycling infrastructure;

- (b) what are the plans for cycling infrastructure at the Princess Royal Drive/Hanrahan Road flyover; and
- (c) can a cycle path be built prior to the slurry pipe for Grange Resources being constructed?

## 8512.Mr P.B. Watson to the Minister representing the Attorney General

Can the Attorney General confirm that the Department has informed the Royal Association of Justices Western Australia that they will be ceasing a \$50,000 funding grant to the Association, and if so:

- (a) when will this funding cease; and
- (b) why is this funding being withdrawn?

## 8513.Mr P.B. Watson to the Minister representing the Minister for Education

In relation to the finance and administrative systems used in schools, I ask, is the Department of Education using a system supplied by RM Finances to run finance and administrative systems in schools, and if so:

- (a) is that system still supported by its developer;
- (b) how many years has the Department of Education had that system; and
- (c) are there plans to replace it, and if so has any cost estimate been done on a replacement?

# 8514.Mr P.B. Watson to the Minister representing the Minister for Education In relation to independent public schools (IPS), I ask:

- (a) how much has been spent training the principal and registrar for each IPS;
- (b) will principals and deputy principals in non-IPS schools have access to the same training opportunities;
- (c) will this restrict the career paths of those in non-IPS schools;
- (d) is the money being spent on training coming from the closure of District Education Offices, and if not, where is it coming from;
- (e) what are the selection criteria for schools applying to be IPS;
- (f) why is it that some schools that are selected to be IPS are being managed just as well as those not being selected; and
- (g) how many level 3 schools are there, and how many of those have applied to be IPS?

#### 8515.Mr P.B. Watson to the Minister representing the Minister for Education

In relation to those primary schools in the South West and Wheatbelt regions, I ask:

- (a) which schools in each of these regions do not have a substantive position principal;
- (b) what are the reasons for this;
- (c) will any of these schools have a principal with a substantive position appointed to them; and
- (d) are there any plans to close any of these schools, and if so, which ones?

## 8516.Mr W.J. Johnston to the Minister representing the Minister for Energy

How many megawatt hours of electricity were supplied to customers by Synergy in the years 2009, 2010, 2011 and 2012 to date in accordance with Smart Power tariffs of the following categories:

- (a) weekend shoulder;
- (b) weekend off-peak;

- (c) summer weekday shoulder;
- (d) summer weekday peak;
- (e) summer weekday off-peak;
- (f) winter weekday peak;
- (g) winter weekday shoulder; and
- (h) winter weekday off-peak?

#### 8517.Mr R.H. Cook to the Minister for Health

I refer to colonoscopies in all public hospitals, and privately-operated hospitals treating public patients (Peel Health Campus and Joondalup Health Campus), and ask:

- (a) what is the current average waiting time for category 1 patients requiring a colonoscopy, listed by hospital;
- (b) what is the current average waiting time for category 2 patients requiring a colonoscopy, listed by hospital;
- (c) what is the current average waiting time for category 3 patients requiring a colonoscopy, listed by hospital;

- (i) is the Government going to be able to cater for the increased number of screenings under the National Bowel Cancer Screening Program?

I refer to Kaleeya Hospital which currently provides maternity, gynaecological and some surgery for public patients, and ask:

- (a) what are the Government's intentions for services at this Hospital when Fiona Stanley Hospital opens;
- (b) what services, if any, will remain at the hospital when Fiona Stanley Hospital opens;
- (c) how many babies have been born to public patients at Kaleeya each year since 2008, listed by year;
- (d) how many operations have been performed on public patients at Kaleeya each year since 2008, listed by year;
- (e) what surgical procedures are currently undertaken at Kaleeya;
- (f) what is the current land use zoning, and physical size of the site at Kaleeya;
- (g) are there any proposals underway to re-zone the site; and
- (h) does the Government intend to sell the Kaleeya site?

#### 8519.Mr P.C. Tinley to the Minister for Housing

I refer to a Department of Housing property at Lot 85 on Plan 1547 as shown on certificate of title 2173/253 known as 66 Murray Road, Bicton, and I ask:

- (a) was any contractor or worker at this site potentially exposed to asbestos contamination prior to remedial work being undertaken at this site, and if so, have they been advised of this potential exposure;
- (b) has asbestos contamination of the soil at this site been completely remediated or does there remain a risk of asbestos soil contamination;
- (c) if yes to (b), what measures have been taken to advise tenants at this property and also to inform any potential buyer if the property were to be sold in the future; and
- (d) what provision has been made to ensure maintenance workers attending the site are aware of the potential hazard in lifting brick pavers, or conducting other maintenance work that involves disturbing the soil?

## 8520.Mr P.C. Tinley to the Minister for Housing

I refer to a Department of Housing property at Lot 85 on Plan 1547 as shown on certificate of title 2173/253 known as 66 Murray Road, Bicton, and I ask:

- (a) on what date did the demolition of the property at this site commence;
- (b) on what did the Department become aware of possible asbestos contamination of the soil at this site;
- (c) did the Department receive formal notification that the Department of Environment and Conservation were looking into possible asbestos contamination at this site, and if so, on what date;
- (d) did demolition, earth or construction works stop at this site as a result of concerns about possible asbestos contamination, and if so, on what dates was work stopped;
- (e) did the Department of Housing have an Occupation Health and Safety (OHS) plan for this site, if so:
  - (i) on what date was the OHS plan approved;
  - (ii) did the original OHS plan include reference to asbestos or possible asbestos contamination at the site; and
  - (iii) was the OHS plan ever amended to include asbestos or possible asbestos contamination at this site and if so, on what date; and
- (f) did the Department notify local residents of concerns about possible asbestos contamination on site, and if so, how were residents notified, and on what date/s?
