1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

New Courthouse and 24 hour Police Station for Armadale – Dr A.D. Buti presented a petition from 1,822 persons requesting that a new courthouse and a 24 hour 7 day a week public access police station in the City of Armadale be provided (P. 592).

New 24 hour Police Station for Armadale – Mr A.J. Simpson presented a petition from 10,152 persons requesting that the Legislative Assembly implements the request for a 24 hour police station in Armadale (P. 593).

Proposed Hammond Park High School – Mr F.M. Logan presented a petition from 249 persons requesting that the Legislative Assembly immediately brings forward the development and construction of a High School at Hammond Park (P. 594).
