That, pursuant to recommendation of the Joint Standing Committee on Delegated Legislation, the *City of Subiaco Waste Local Law 2022* published in the *Gazette* on 14 March 2023 and tabled in the Legislative Council on 21 March 2023 under the *Waste Avoidance and Resource Recovery Act 2007*, be and is hereby disallowed. #### 8. Implementation of the Aboriginal Cultural Heritage Act regulations

Hon Neil Thomson: To move on the next day of sitting —

That this House —

- (a) shares the extraordinary level of concern expressed by the community about how unprepared the State is in the implementation of the Aboriginal Cultural Heritage Act regulations with a record number of signatures received on an electronic petition in a very short time frame;
- (b) notes the expression of anxiety and concern of landowners and small and medium businesses sector, including pastoralists and graziers, farmers and any contractors or individuals who might need to carry out ground disturbing activity after 1 July 2023 regarding their ability to comply with the new regulations;
- (c) notes the deep concern that the Department of Planning' Lands and Heritage's Permit System will only be operational on 1 July, meaning applicants will need to cease work while they wait for approvals to be processed after 1 July 2023;
- (d) notes the concern that no Local Aboriginal Cultural Heritage Services (LACHS) are yet registered and the associated concerns expressed by

- traditional owners about implementation of the new laws and challenges establishing LACHS;
- (e) notes that many in the community, including landowners in the metropolitan area, have not been aware of the changes and their obligations under the new Act and this cohort are only now just becoming aware of how the new laws might impact on them; and
- (f) calls on the Cook Government to delay the promulgation of the regulations by at least six months to alleviate anxiety in the community, reduce the risk of business disruption, establish functioning and tested systems, ensure LACHS are properly resourced and functioning, and provide better advice to all parties that are affected, including residential land owners who have blocks greater than 1,100m<sup>2</sup>.

#### 9. Electoral Amendment Bill 2023

Non-Government Business No. 1 having been called, Hon Dr Brad Pettitt pursuant to notice, moved —

That a Bill for "An Act to amend the *Electoral Act 1907*." be introduced and read a first time. Question — put and passed.

Bill read a first time.

Hon Dr Brad Pettitt moved, That the Bill be read a second time.

Hon Dr Brad Pettitt tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 2292). Debate stands adjourned.

#### 10. Political Donations Reform

Non-Government Business No. 2 having been called, Hon Dr Brad Pettitt moved, without notice — That this House —

- (a) notes the State Government's unrealised commitments related to political donations reform in both the 2017 State Election and the *Electoral Amendment Act 2020*; and
- (b) calls on this Government to at a bare minimum, legislate their own commitments to reform political donations laws by
  - (i) developing an online disclosure register for political donations;
  - (ii) lowering the political donations declaration threshold to \$1,000;
  - (iii) closing the disclosure loophole by removing the option for political parties and associated entities to lodge a Commonwealth return to satisfy State requirements;
  - (iv) banning foreign political donations;
  - (v) reviewing disclosure arrangements for third-party fundraising bodies;
  - (vi) capping electoral expenditure during elections; and
  - (vii) implementing quarterly reporting requirements.

Debate ensued.

That the Legislative Council acknowledges the retirement of the Hon Mark McGowan, former Premier and Member for Rockingham, and his significant contribution to Western Australia.
